REP. GOODWIN: The agency head, list and for those of you from selt 1 the general public especially, I apologize for the lack of facilities for us to get started with this morning. We would have done it around the Circle except that the accoustics is so bad. Really the only way you can hear is with the room set up this way. If we have to, we may bend the rules a little bit this morning, but we'll try to be as expeditious as possible.

The first speaker on the list is Terry Roberts. She will be followed by Bob Suerken.

MS. TERRY ROBERTS: My name is Terry Roberts. I'm the Superintendent of Special School District of the Department
of Mental Rétardation and I'd just like to make a couple
of brief comments about No., 882 and 7076. The first,
882, is concerning the status of children in the private
réhabilitative nurseries. There are four of those in the
state. Since the inception of the special school district,
we have been educating those children and carrying the
educational responsibility for them.

The statute did not really clarify their status and this change in the language would in fact, then make it quite clear that we should and will continue to carry the educational responsibility for those students whom we place in those four nurseries.

- MS. ROBERTS: (continued)
 - The second, 7076, is the Bill concerning the change of name for the special school districts in Corrections, DCYS and the Department of Mental Retardation. Although the issues around this name change do not effect the students who attend the special school district of the Department of Mental Retardation, we endorse the kinds of issues that Corrections and DCYS have had and we have no objection to having our name changed if it will help those students in the future.
- REP. GOODWIN: Thank you Terry. Are there any questions?
 Thank you. The next speaker, Bob Suerken, followed by Richard Olsen.
- MR. ROBERT SUERKEN: Good morning Madam Chairwoman, Mr. Chairman and members of the Committee, my name is Bob Suerken. I am Superintendent of Schools of the Department of Children and Youth Services and I'd like to address my comments to House Bill 7076.

House Bill 7076 provides for a change in the name of the three special school districts in the state of Connecticut. I ask your support of this legislation because the Department of Children and Youth Services feels that the current title, Special School District may often be construed as a negative reference or possible stigma in the educational history of an individual:

Many students who are enrolled in the three state operated school districts are not educationally handicapped and therefore should not be labelled with terms such as special or correctional as they perceive to develop plans for adulthood. Indeed, no student, irrespective of educational status should be inadvertently labeled with the name of his or her school district. Persons requesting transcripts in order to facilitate applications for employment or future education could be adversely effected by terms like special school district, children and youth service special school district or correctional school district. The mission of each of the three state operated school districts is to prepare children, youth and young adults to be productive, contributing members of society. The term such as special school district can only detract

from this worthy mission. It is specifically for this reason that the Department of Children and Youth Services wishes to change the designated name of the three special school districts to the State of Connecticut Unified Districts #1, #2 and #3. The terminology Unified School District accurately describes all three of the state operated school districts while clearly separating them from the Regional School District concept in Connecticut. The name change will further serve to promote a professional image that will not detract from the students opportunities for future growth and development. The basic intent of this proposed legislation is to safeguard the dignity of every student enrolled in state operated institutional schools and to promote and enhance each individual's potential for further advancement and training.

It is for all of the reasons stated that I urge for passage of House Bill 7076.

- REP. GOODWIN: Thank you. Are there questions? Thank you very much, Bob. Richard Olsen, followed by Bob Margolin.
- MR. RICHARD OLSEN: Good morning Madam Chairman. My name is Richard Olsen. I'm Assistant Superintendent of the Correction School District. I'm here this morning to speak in behalf of Bill 7076, An Act Concerning Changing the Name Designation of the Special School Districts.

Ladies and gentlemen, House Bill 7076 makes provision for a change in the name of Connecticut's three special school districts. I request your support of this legislation. These districts provide for recognition and education of an individual completing a variety of educational program offerings. Completion of one's high school education program has long been recognized as a right to passage in American society. Such effort should compromise a milestone in one's development as an individual and a citizen. However, if the documentation attesting to the completion carries a label such as Correction School District, Children and Youth Services School District or Department of Mental Retardation School District, it is difficult to display with pride and dignity, the certificate of completion. Rather, it causes the student who has put

forth such effort to carry always a label of past actions which he or she would prefer to leave behind. It is for the above stated reasons that House Bill 7076 is submitted. The term Unified School District Nos. 1, 2, and 3, is appropriate as the special school districts serve the state of Connecticut at large. Your favorable review of this proposed legislation will provide a mechanism by which those individuals who put forth the energy and diligence to better themselves educationally may display with dignity, the result of such efforts.

It is to this end that House Bill 7076 has been proposed. Thank you.

- MR. OLSEN: I can speak for my own district which is the Department of Correction. We handle between eleven and twelve hundred students per year.
