## TESTIMONY OF ATTORNEY GENERAL RICHARD BLUMENTHAL BEFORE THE ENVIRONMENT COMMITTEE FEBRUARY 26, 2003

I appreciate the opportunity to speak in support of House Bill 6423, An Act Concerning Enforcement of Pollution Abatement Orders.

Under current law, Conn. Gen. Stat. Sec. 22a-430, if the Commissioner of Environmental Protection determines that any person is polluting the waters of this state, the Commissioner may issue a pollution abatement order or request the Attorney General to seek a court order to enjoin such pollution.

In some cases, my office has sought a court order to stop the pollution and a court order to clean up the pollution or repair any damage caused by such pollution. Some defendants have challenged whether my office may seek a court order to remediate the effects of the discharge into state waters.

House Bill 6423 simply clarifies that the Attorney General may seek such additional remedy. The environment would be better protected and judicial resources more effectively used, if the court orders the polluter to restore the waters to its original condition as well as to stop the contamination.

I urge the committee's favorable consideration of House Bill 6423.
