THE CONVEYANCE OF CERTAIN PARCELS OF STATE LAND. The bill is accompanied by emergency certification, signed Donald E. Williams Jr., President Pro Tempore of the Senate; Christopher G. Donovan, Speaker of the House of Representatives.

#### SENATOR SLOSSBERG:

Thank you, Mr. President.

I move passage of the emergency certified bill in concurrence with the House and seek leave to summarize.

### THE CHAIR:

Acting on approval of the bill, ma'am, would you like to further remark?

## SENATOR SLOSSBERG:

Yes. Thank you, Mr. President.

## THE CHAIR:

Please proceed.

## SENATOR SLOSSBERG:

This is our annual conveyance bill. It authorizes conveyances of state property from all the way from Bridgeport to Windham and towns in between for both recreational, municipal and economic

purposes.

Thank you, Mr. President.

### THE CHAIR:

Thank you, ma'am.

Will you remark further on House Bill 7003? Will you remark further?

If not -- Senator McKinney.

Thank you. It was the moving hand. I didn't see you there.

### SENATOR McKINNEY:

I moved, Mr. President. Thank you. I apologize.

Mr. President, this is a unique conveyance bill.

We passed one during regular session. I appreciate

all the hard work Senator Slossberg put into this.

There are lots of very good things for a lot of towns.

I voted for it during regular session and believe the bill was vetoed by the Governor.

My concern is that, when we voted on this package the first time, we did not then know that our budget would be expecting \$60 million from the sale of state assets. Now that 60 million is money that those of us on -- in our caucus, criticized as being unidentified and, perhaps, unobtainable and might lead to further deficits for the State of Connecticut.

But I think we made a choice in passing the budget that we were no longer going to simply give away state assets. I think we made a choice that now, because of our tough economic times, we were going to look to sell those assets rather than simply give them away.

Now, we've always done that through conveyance bills, and I've never objected to a conveyance bill, that I can remember, but I believe with that budget we changed our policies. And this, in other years, is a very good; bill, but to give away all of these properties and then expect that we're going to get \$60 million through selling other properties, I think, is inconsistent and, therefore, for the first time that I can recall, will be voting in opposition to the conveyance bill.

Thank you.

## THE CHAIR:

Thank you, sir.

Will you remark further?

Senator Witkos.

#### SENATOR WITKOS:

Thank you, Mr. President.

I apologize for speaking after the Republican

leader. I did have one question, if I may. And I'm not sure who direct this to. Maybe somebody from the City of Bridgeport will be able to answer this because all I had was the OLR analysis, and there's a provision in here that says that the DEP would give to Bridgeport two parcels of land. One of those is a 33-acre tract, which is located in the city of Trumbull, and that would be used to build a regional magnet high school. There's some conditions. It has to be built within ten years, or the property has to be maintained as a public park with the restriction recorded in the Trumbull land records.

## SENATOR SLOSSBERG:

I can't answer that question definitively, but rather only speculate that in order for it to become a

project that would receive pilot reimbursement, that would have to be -- have to go through an additional process here at the state level. So the best that I can tell you is that I don't know in terms of what would happen with pilot dollars, but additional -- there would -- require additional language here at the Legislature in order for pilot funding to occur.

And I don't mean to belabor the point, but is there a plan through the Department of Education, at this point, to build a regional magnet high school within the City of Bridgeport on this property?

## SENATOR WITKOS:

Mr. President -- and I thank the Senator for her

answers.

We're moving to adopt a piece of legislation that proposes to remove some land currently located within the City of Trumbull and move those boundary lines over to the City of Bridgeport.

And I've -- I'm not -- I'm a short timer up here.

I've only been up in the capital -- this is my seventh year, but I've never seen that in any of the conveyance bills before. It's always been from the State to an individual or the State to an individual community. Never before have I seen boundary lines of local communities transferred to a different community. And then they're being transferred to a purpose, which we don't even know if it's even gone through the stages of public hearings or approvals through the Department of Education to build such a magnet school. And I don't even know if that's in the statewide Department of Education plan. Maybe Senator Gaffey could speak to that when he returns to the chamber.

But I think that we're setting a bad precedent here just with that one provision. I really didn't see anything else in the bill on my cursory view, but that stood out, alarming to me. I looked in the House

to see if there was any debate on that. And oftentimes, bills like this go through. They slide right through unanimously because they make a good sense -- but not in this case.

So with that, I will be opposing the bill.

## SENATOR MUSTO:

Thank you, Mr. President.

Just, although Senator Witkos' questions were not addressed to me, I think I do have a couple of the answers.

Senator Witkos -- through you, Mr. President to

Senator Witkos, I am not sure what the status of -with the Department of Education is the State

Department. I have talked to Mayor Finch in

Bridgeport, formerly of this seat, and have discussed

building the school with him. He intends that it will

be one of the greenest schools in the state of

Connecticut and is going to take much of the

technology that we are trying to incorporate into our public buildings and trying to make it a model for that school and for the State of Connecticut. In addition it is anticipated that children from the surrounding areas, including Bridgeport and Trumbull will attend that school, as far as the interdistrict part of the magnet school goes.

And so for those reasons -- what I don't think is happening, though, which Senator Witkos seemed to allude to -- I'm not sure frankly -- is that there's any border change between the towns. It's also the case, as we remember in Stratford, that Bridgeport owns an airport that is not within its borders. The fact that Bridgeport may own the land does not mean that it is part of the city of Bridgeport. It is simply a title issue in my understanding.

So I'm not concerned with us moving the boundaries for this purpose. It should benefit my entire district. And certainly, the plans have been in place. I've seen plans for the school. Whether those have been approved by the Department of Education is something I simply cannot answer at this time.

But I do thank Senator Witkos for bringing these
