Good day. My name is Pete Gioia. I am the economist for the Connecticut Business and Industry Association (CBIA). CBIA represents about 10,000 firms, which employ about 700,000 women and men in Connecticut. Our membership includes firms of all sizes and types, the vast majority of which are small businesses with fewer than 50 people.

CBIA would like to comment upon the following bills: SB 372, SB 373, SB 374, SB 375, HB 5413, HB 5414, HB 5415, and HB 5416. CBIA is encouraged that the committee is calling for review of high spending areas in the budget. We recommend that these efforts proceed immediately and with great urgency.

#### SB 372

CBIA supports efforts to increase transparency in the budget and aid the committee in sound deliberations.

#### SB 373

CBIA supports efforts to increase awareness and oversight of DOC spending. Over the past 20 years the DOC budget has grown far in excess of overall spending increases. Serious review is long overdue.

#### SB 374

CBIA supports efforts to increase awareness and oversight of judicial related spending.

Over the past 20 years this area budget has grown far in excess of overall spending increases.

Serious review is again long overdue.

#### SB 375

CBIA supports efforts to increase awareness and oversight of public and mental health and developmental services related spending. Over the past 20 years these budgets have grown far in excess of overall spending increases. Serious review is again long overdue.

#### HB 5413

CBIA supports efforts to increase awareness and oversight of social services related spending. Over the past 20 years this area budget has not only grown far in excess of overall spending increases, but serious discrepancies between what private nonprofit providers get paid for similar work done by state workers is a fairness and equity issue. This and DOC should be the top priorities in these reviews

#### HB 5414 and HB 5416

Given the huge role of DOE and of DHE better review of their spending would be a plus.

#### HB 5415

Certainly OFA should review high growth areas. But, we would also like to see a review of the largest and most costly areas -high growth or not. The committee needs to review the
