(Speaker Donovan in the Chair.)

SPEAKER DONOVAN:

All right. We are about to do another bill. But before we do, I'd like -- we had a call to the bullpen and we got -- are you left or right-handed?

A VOICE: Right-handed.

SPEAKER DONOVAN:

We've got a right-hander coming in. Also from the Class of '93, our good friend, the Chairman of Environment, Richard Roy.

(Representative Roy in the Chair.)

SPEAKER ROY:

Will the Clerk please call Calendar Number 262?

THE CLERK:

On page 10, Calendar 262, House Bill number 5497,
AN ACT IMPLEMENTING THE RECOMMENDATIONS OF THE
LEGISLATIVE PROGRAM REVIEW AND INVESTIGATIONS
COMMITTEE CONCERNING THE REGULATION OF HEARING
INSTRUMENT SPECIALISTS AND AUDIOLOGISTS, favorable
report by the Committee on Public Health.

SPEAKER ROY:

Thank you.

Representative T.R. Rowe of the 123rd.

REP. ROWE (123rd):

Thank you, Mr. Speaker. Pleasure to see you up there and we'll see if we can get this through without too much incident, but I move the Joint Committee's favorable report and passage of the bill.

SPEAKER ROY:

Thank you.

It's acceptance of the favorable report and passage of the bill.

Will you remark?

REP. ROWE (123rd):

I will. Thank you, Mr. Speaker.

This is a program review investigation bill which came out as a consequence of a study that was actually part of the sunset program. We were looking into the hearing aid specialists and the audiologists, and as a consequence of this study and the public hearing that we held in connection with the study, there are essentially two recommendations that the bill sets forth and implements.

The first concerns audiologists, and currently audiologists within their scope of practice are

allowed to do many things, and that includes the fitting of hearing aids. However, because of a redundancy in the law, there is also a statute which requires these audiologists, these same audiologists to go through additional training in order to do that. So, that's the first part of the bill.

And the second part is affected by an amendment. So, if I may call LCO Number 4175 and I be allowed to summarize.

SPEAKER ROY:

Will the Clerk please call LCO 4175, which will be designated house amendment Schedule "A".

THE CLERK:

LCO4175 house A offered by Representative Rowe and Representative Mushinsky.

SPEAKER ROY:

Will you summarize?

REP. ROWE (123rd):

Sure. This amendment does the second part of what I had talked about earlier, and it sets forth some continuing education requirements for the hearing aid specialist. The first part dealt with the audiologists and this deals with the hearing aid specialists and sets forth essentially a 16-hour

requirement every two years that the hearing aid specialists need to be relicensed. This was requested by both the department and the hearing aid specialists, and I would move adoption.

SPEAKER ROY:

Thank you.

The question before the Chamber is adoption of the House amendment 4175.

Will you remark on the amendment?

Representative Mushinsky.

REP. MUSHINSKY (85th):

Thank you, Mr. Speaker.

This amendment is a good amendment. It does -- the current law does not require continuing education as a condition of licensure renewal. With this amendment we will be dealing with a rapidly changing field where there are technical advances every few years, and better protect the public who will be well served by continuing education requirement for these providers. So, I hope you will join me in supporting this bipartisan amendment.

Thank you, Mr. Speaker.

SPEAKER ROY:

Please speak -- any others wishing to speak?

Representative Miller of the 122nd, sir.

REP. MILLER (122nd):

Thank you, Mr. Speaker. I have a question or two to the proponent of the amendment.

SPEAKER ROY:

Proceed, sir.

REP. MILLER (122nd):

The last section of the amendment, lines 41 to 45, there is an eight-hour requirement for a course. Is that an all-day affair or does it have to take two sessions, or how does that work?

Through you, Mr. Speaker.

SPEAKER ROY:

Representative Rowe.

REP. ROWE (123rd):

It's a tremendously insightful question that I will respond to by saying the bill is silent -- the amendment is silent on that. So, that eight hours can be drawn out, I suppose, however the continuing education entity sees fit.

Through you.

SPEAKER ROY:

Representative Miller.

REP. MILLER (122nd):

And through you, Mr. Speaker, I don't suspect there are going to be a lot of people taking the course, so, where would this be held? Would it be held here in Hartford or in the gentlemen's area, for instance, Fairfield County, New Haven County, where?

Through you, Mr. Speaker.

SPEAKER ROY:

Representative Rowe.

REP. ROWE (123rd):

Thank you.

Through you, I expect that the audiologist industry and association will make the continuing education process as appropriate and convenient for their members as it needs to be. I wouldn't be surprised if there were continuing education opportunities throughout the four corners of Connecticut.

Through you.

SPEAKER ROY:

Thank you. Representative Miller.

REP. MILLER (122nd):

Yeah, thank you.

And again through you, Mr. Chair -- Mr. Speaker, what would be the cost to the individual for taking

It will be simply to cover the expenses. And in any event, the public hearing testimony or the testimony that we received back was not -- there were not concerns about costs, through you. In any event, it won't cost the State any money.

RICHARD USIFER: (Inaudible) a mandatory continuing education for hearing care providers and the reason is the past 20 years have -- have shown an explosion of new technologies in our industry. When programmable hearing aids came out about 20 years ago, hearing aid fitting instantly became more challenging.

What we used to do with screwdrivers and lamb's wool, and I can tell you because I used to use that, was now done with computers and real ear measurement. The consumers had to be careful at that time due to the potential for people to sell expensive products without having the expertise or the competency to fit them. And consumers had no easy way to know if dispensers had that training. This is why we feel continuing education is more important now than it ever was.

As far as monitoring CEUs, that would be

incumbent on the licensee so there'd be little or no extra work for DPH. License renewal applications already have a box which the licensee has to check for certain professions to affirm they have met continuing ed requirements. We'd just be adding our name to that list.

There'd be no -- little or no additional cost to dispensers. Manufacturers offer accredited seminars within easy driving distance at no charge to promote their products. And CEUs are also available online at minimal cost.

Many dispensers will attend a convention that could cover all their CEUs for that year or even for the two-year period.

So, in conclusion, CHADO for the nas -- the past nearly 50 years has always stood up for the best interests of consumers and hearing aid specialists in our state. There are other pressing concerns in our industry, including Internet and mail order hearing aids, but we feel this bill will help consumers by continue -- continuing regulation and expanding education.

And I thank you for your attention, and I'm happy to answer any questions.

REP. ROWE: Thank you, Mr. Usifer. You know far more about this, certainly, than me and, I reckon, Senator Markley as well. So it's -- it's good and important to have your sign-off as it were on the proposal.

THE LEGISLATIVE PROGRAM REVIEW AND INVESTIGATIONS COMMITTEE
CONCERNING THE REGULATION OF HEARING INSTRUMENT SPECIALISTS AND
AUDIOLOGISTS**

Committee members:

My name is Richard Usifer, and I am president of the Connecticut Hearing Aid Dispenser's Organization (CHADO). Our group consists of hearing instrument specialists and audiologists in Connecticut.

CHADO strongly supports the recommendations of the February 22nd report from the Office of Program Review and Investigations on hearing instrument specialists. I worked closely with Ms. Kluger, who wrote the report, over the past several months. Her thorough report covers every aspect of hearing aid dispensing in the State of Connecticut, particularly relating to consumer protection.

Essentially, her report supports the status quo except for two areas. I won't reiterate her rationale for keeping the current system, which serves consumers well without being onerous to dispensers. We have no issue with removing the remaining hearing aid licensure requirement for audiologists. I want to focus on the recommendation for Continuing Education, which is crucial to protecting consumers.

We favor mandatory continuing education for hearing care providers. The past 20 years have seen an explosion of new technologies. When programmable and digital aids came out 20 years ago, hearing aid fitting instantly became much more challenging. What we used to do with screwdrivers and lamb's wool was now done with computers and real-ear measurement. Consumers had to be careful due to the potential for people to sell expensive products without having the training or competency in fitting them. And they had no easy way to know if dispensers had that training. This is why we feel continuing education is more important now than ever.

Monitoring of CEUs would be incumbent on the licensee, so there would be little or no extra work for DPH. License renewal applications now have a box which the licensee must check to affirm that they have met continuing ed requirements. There would be little to no additional cost to dispensers for CEUs. Manufacturers offer several

accredited seminars within easy driving distance at no charge to promote their products. CEUs are also available online at minimal cost. Many dispensers will attend a convention which would cover all of their CEU needs for that year.

To conclude, CHADO for the past nearly 50 years has always stood up for the best interests of consumers and hearing instrument specialists in our State. There are other pressing concerns in our industry, including internet and mail order hearing aids, but we feel that this bill will help consumers by continuing regulation and expanding education.
