Mr. Speaker, this bill directs the Department of Consumer Protection to amend its regulations to allow a licensed professional engineer to take a hiatus from practicing in Connecticut by surrendering his or her license to the State Board of Examiners for professional engineers and land surveyors at the beginning of the hiatus and receiving a new license at the end.

The bill provides that the professional engineer would not be required to pay the \$225 annual license renewal fees for the period of the hiatus to receive a new license and is currently -- as it is currently required in some cases now.

Mr. Speaker, this bill is effective upon passage.

As stated, it has already passed the Senate, which it did unanimously. It also passed the General Law

Committee unanimously. There's minimal fiscal impact.

On Page 3, Calendar 165, <u>Senate Bill Number 327</u>, AN ACT CONCERNING ENGINEER LICENSES, Favorable Report of the Committee on General Law.

THE CHAIR:

Good evening -- I mean good afternoon, Senator Doyle.

SENATOR DOYLE:

Good afternoon, Madam President.

I move acceptance of the joint committee's Favorable Report and passage of the bill.

THE CHAIR:

The motion is on acceptance and passage. Will you remark, sir?

SENATOR DOYLE:

Yes. Thank you, Madam President.

This bill, which was voted unanimous out of the General Law Committee, 18-to-0 vote, deals with the issue of engineer's licenses. It was brought to attention of one of our colleagues in the Chamber here that an engineer, who was legally practicing in the State of Connecticut and decided to move to Rhode Island and practice his engineering practice up in Rhode Island, up in, up in New Hampshire for, like, ten years, then he came back to Connecticut and tried to reengage and begin his practice here. He was told by the Department of Consumer Protection that he had to pay; in order to get reinstated and fully practice here in Connecticut again, he had to pay for the ten years of fees that he was practicing in New Hampshire. So rather than reinstatement fee, he had to pay the reinstatement fee plus the -- the ten years that he wasn't practicing in the state, which certainly is not an appropriate fee to make our state business friendly and even, you know, makes very little common sense.

So what this bill does to try to address this flaw in our regulations, we, we're directing the Commissioner of Consumer Protection to amend the regulations to set up an arrangement or apparatus whereby a duly licensed engineer can surrender his existing license to the -- the State Board of -- of Examiners for Professional Engineers and Land Surveyors, kind of have them surrender it and have them hold it. And then if the

engineer decides to come back to Connecticut, he can, he can reapply for it, get his license back without having to pay the ten-year gap; he just pays the reinstatement, a small reinstatement fee, and then he can move forward to practice again.

So this -- this is a business-friendly bill that corrects an injustice, and I urge the Chamber to approve this bill.

Good afternoon, Madam President.

I just wanted to stand and thank Senator Doyle, because this happened and this occurred in my district; in fact, in Tolland. An engineer who moved to New Hampshire to take care of one of his parents, stayed up there for a period of 17 years, came back and was told he owed all the back fees, plus interest, plus penalty. And it was certainly some confusion between the Department of Consumer Protection and the Attorney General's Office, how it was interpreted, and this — this will straighten that out so that doesn't happen again.

And in his case, he really was not able to get back into engineering work. Fortunately for him, he's teaching at the University of Connecticut, so maybe he's better off. But he was a lucky -- lucky one. There's many others that are probably in the same boat that we don't even know about, and I just want to thank the good Senator for moving forward what I think is a real common-sense piece of legislation.
