Thank you, Mr. Speaker. Mr. Speaker, this bill would change the current law. Currently, if a pet owner files a complaint with the Department of Public Health against a veterinarian, the records that are used in the Department of Public Health's investigation of that complaint are confidential and remain confidential both during the investigation and after the investigation is concluded. This would change the law and allow the owner of the pet who filed the complaint to have access to those records to see what records were used in the determination by the Department as to whether probable cause exists to go forward with a more full investigation, and my understanding is that an amendment will be filed that will be an improvement to this bill and I look forward to that Mr. Speaker. Thank you.

DEPUTY SPEAKER MORRIS (140TH):

REP. HARDING (107TH):

Thank you, Mr. Speaker. Good morning Mr. Speaker. Mr. Speaker, I just have some comments to make and an amendment to propose. Just like Representative Demicco stated that this is supposed to be for owners to see the file in regard to veterinarian complaints filed with the Department of Public Health. Right now, the language is written in the bill that is currently before us states that any person who is responsible for the custody or control of such an animal, and that's written in addition to the owner. So, it broadens that language a little bit and it might open it up to some individuals who may not--you know is supposed to be privy to this particular information.

So, that being said, Mr. Speaker, the clerk has an amendment as LCO 6247. I would kindly ask the clerk to call it and I'd be allowed to summarize?

DEPUTY SPEAKER MORRIS (140TH):

Will the clerk please call LCO 6247, designated as House Amendment Schedule "A"?

Committee is <u>House Bill 6347</u>. I thank you for raising it. It is requiring the Department of Public Health to provide findings to complainants concerning complaints of wrongdoing against veterinarians. I expect that this morning you've heard stories or will be hearing stories throughout the day about people who have lost their pets, whom they consider to be family, to what they consider to be a mistake on the part of the veterinarian or the veterinarian hospital.

My first exposure to this came through an 80-year-old World War II Veteran, who had a small dog that he had made the very difficult decision to euthanize. And when he went to have the dog euthanized, he had a really bad experience. They were unable to find a vein on the dog. The dog whimpered and cried and howled. And when they did administer the, well, I won't call it a medication the drug, they didn't have the proper drug or the proper amount, and it was a horrifying experience.

But what I am here for on that is he subsequently, and I'm sure that you heard from Representative Santiago too on this and there have been numerous people that have been in touch with us, he subsequently asked for a determination from the Department of Public Health on whether this was the proper criteria that was followed. He received back a one-line letter stating, and I quote, "The Department has concluded that no violations of the statutes governing veterinarian practice had been identified; therefore, the case is closed." This determination, I might add, takes many months and the complainant is never involved as far as seeing

any of the records examined or transcripts of any interviews that took place.

What this bill is proposing is saying that the Department of Public Health has made a legal determination and as such, this determination should be appealable in Superior Court, much as any license or permit denial is appealable or CHRO Ruling is appealable. If the complainant feels strongly that they would like access to and review of all the material the Department used to make their decision, then he or she has that option of taking it to Superior Court. This is not intended to hurt veterinarians or their reputation. It's directed at a legal determination of an agency, in this case, the Department of Public Health, which should be appealable in Superior Court.

I'll just comment briefly on House Bill 5499, the Sunday hunting bill. I am surprised that the Committee has gone to guns on Sunday. I was a longterm member of this Committee, and when we did move to Sunday hunting, we all agreed that it was bone and arrow, it was different than having guns out on a Sunday, when people are on public land, enjoying themselves, and I realize that this is on private land, but I would remind people that private land abuts public land as well as abuts private land. My own home, I have a riding ring that is abutted on three sides by private property that is woods, where hunting takes place. And also in my case, I am a United States Pony Club Coach, I work with kids who are on their little ponies and horses, zooming around, supposedly staying on property where they're supposed to be, but not always staying on the property where they're supposed to be.

And you have a bunch of bills that I'm very much in favor of and I put those in my testimony. I'm glad to answer any questions.

SENATOR KENNEDY (12TH): Thank you, Representative. I have two questions for you. The veterinary bill, I heard anecdotally that actually the State of Connecticut did once have that ability for people to appeal this to the Superior Court, but that a change was made about a dozen or so years ago, way before I got here, to actually change that policy. Can you speak to that, are you aware of, did we once have the ability to, for animal owners, to appeal a decision like this from the Department of Public Health?

REP. URBAN (43RD): Senator, I have been trying to research that because I was under the same impression and it was before I came in as a Rep, also. From all that I can ascertain was changed at some point, but I'm not sure that it was changed from the ability to appeal it to Superior Court. I think if it was changed from the ability to look and be more involved in the records that the Department of Public Health was using in order to make their determination. But I would, you know, acquiesce to OLR or to LCO for a more in-depth, and as I said, I have asked, and that's the impression that I've received.

Good Morning Senator Kennedy, Senator Miner Representative DeMicco and members of the Environment Committee. For the record I am Diana Urban and I represent the 43rd district. I am here this morning to testify on HB 6347, HB6335, HB5499, and SB522.

I would like to thank the Committee for raising HB 6347 AA Requiring the Department of Public Health to Provide Findings to Complainants concerning complaints of wrong doing against veterinarians. I expect that you will hear stories from people who lost pets that they consider family to what they consider to be a mistake on the part of the veterinarian. My first exposure to this came through an 80 year old WWII veteran who had brought his elderly very sick small dog in to the animal hospital to be euthanized. An extremely difficult decision for any pet owner. Unfortunately the whole procedure was botched by a veterinarian technician. The small dog was reduced to whimpering, crying, and outright howling in front of her owner as the veterinarian technician could not find a vein and when he finally did he did not administer the proper drug or the proper amount. It was a horrifying experience.

The veteran subsequently asked for a determination from the Department of Public Health. He received back a one line letter stating "the Department has concluded that no violations of the statutes governing veterinary practice have been identified, therefore the case is closed". This determination takes many months and the complainant is never involved as far as seeing any of the records examined or transcripts of any interviews that took place.

What this bill proposes is recognizing that the Department of Public Health has made a legal determination and as such this determination should be appealable in Superior Court, much as any license or permit denial or CHRO ruling is appealable. If the complainant feels strongly that they would like access to and review of all the material the Department used to make their decision then he or she has the option of taking it to Superior Court.

This is not intended to hurt Veterinarians or their reputation; it is directed at a legal determination of an agency (in this case the Department of Public Health) which should be appealable in Superior Court.

I will briefly comment on HB 5499 only to say when we first discussed Sunday hunting it was recognized that guns on a Sunday were just inappropriate and that

we in the State of Connecticut were going to respect the ability of people to enjoy the woods on a Sunday without the sound of gunshots. I am surprised the Committee is considering this bill. I realize it is on private land but I would point out that those lands often abut other activities. In my case my riding ring has property owned by others on 3 sides. I would urge the Committee to reject this bill as well as the bill authorizing bear hunting (SB522). We have been responding to the habituation issue and I believe it is premature to promulgate a hunting season for bears in Connecticut.

On HB 6335 AA Prohibiting the Sale and Trade of Ivory and Rhinoceros Horn in Connecticut I realize that we have seen this bill before and that there are concerns from antique dealers and you will be hearing extensive testimony from them. I am just going to point out that the elephant is nearing extinction and sale of their Ivory is being used to fund terrorist activity. This is a simple demand/supply equation. Shut down the demand and the price will plummet thus rendering the ivory useless for terrorists.

You have quite an agenda today and I am in favor of the bills addressing animal shelters, Cecil's law, and farmers. I would particularly mention one more and that is HJ 99 Protecting Open Space through the Community Investment Act. I would hope we could move that forward.
