Thank you, Madam President. What this bill does, Bill 417, is it allows --

Good morning. The motion is on acceptance and passage. Will you remark, sir?

SENATOR FRANTZ (36TH):

Yes. Thank you very much, Madam President. What this bill does, Bill 417, is it allows the commissioner's -- the commissioner of Revenue Services to charge fees sufficient to cover reasonable expenses incurred by that department for performing administrative functions including, but not limited to, preparing an account reconstruction, preparing a letter of good standing, etcetera, etcetera, etcetera. A totally fair request on their part.

And what else -- the other area that it focuses on is the area of internet commerce. In the State of Connecticut, there's a big controversial issue and it's before the Supreme Court right now. We expect a decision in June or July of this year in terms of whether states are permitted to collect taxes -- sales taxes on purchases made out of state, coming into their particular state. So we're paying very, very close attention to this. What this bill does is it says that by 2020, if the Supreme Court has either made up its mind or not made up its mind, Connecticut will be in a position to tax these transactions through the folks who make these sales.

So, you have marketplace facilitators who -- like EBay and others who basically provoke these kinds of sales. And what we're saying in Connecticut is that we need to make them responsible for being able to collect those taxes and, in some cases, make the sellers in other states know that there is a state -- potential state tax liability and they need to

make that known to the people who are purchasing from them.
