The bill passes in concurrence with the Senate.

The Chamber will come back to order. Will the clerk please call Calendar No. 92?

CLERK:

On page 5, Calendar 92, Substitute House Bill No. 5360, AN ACT CONCERNING REVISIONS TO CERTAIN ENVIRONMENTAL QUALITY AND CONSERVATION PROGRAMS OF THE DEPARTMENT OF ENERGY AND ENVIRONMENTAL PROTECTION. Favorable report of the Joint Standing Committee on Environment. Representative Demicco, the distinguished chair of the Environment Committee, sir, you have the floor.

### REP. DEMICCO (21ST):

Thank you very much, Mr. Speaker. Mr. Speaker,

I move for acceptance of the Joint Committee's
favorable report and passage of the bill.

DEPUTY SPEAKER RYAN (139TH):

The question before the Chamber is on acceptance of the Joint Committee's favorable report and passage of the bill. Representative Demicco, you have the floor.

#### REP. DEMICCO (21ST):

Thank you, Mr. Speaker. Mr. Speaker, this bill does several things. It allows for leaf compositing facilities to be granted an exemption from obtaining solid waste and water discharge permits under certain conditions. It requires anyone who possesses, breeds, propagates, or sells fallow deer to obtain a game breeder's license from the Department of Energy and Environmental Protection. It allows the commissioner of DEEP to establish and issue lifetime authorizations for hunting and fishing. And, Mr. Speaker, the clerk has an amendment. It is LCO 5686. I'd ask the clerk to

please call the amendment and I be given -- that I be granted leave of the Chamber to summarize.

DEPUTY SPEAKER RYAN (139TH):

Will the clerk please call LCO 5686? It will be designated House Amendment Schedule "A".

CLERK:

House Amendment Schedule "A", LCO 5686 offered by Representative Demicco, Representative Harding, et al.

#### DEPUTY SPEAKER RYAN (139TH):

The representative seeks leave of the Chamber to summarize the amendment. Is there objection to summarization? Is there objection? I'm hearing none. Representative Demicco, you may proceed with summarization.

## REP. DEMICCO (21ST):

Thank you very much, Mr. Speaker. Mr. Speaker, this amendment has several provisions. It -- it directs the commissioner of the Department of Energy and Environmental Protection to adopt regulations regarding the taking of carp by bow and arrow. It also refers to -- makes some changes to the

Department of Agriculture's buy, protect, sell land purchasing procedures. It calls for a working group involving representatives of the apparel industry and the environmental community to be -- to be formed in order to -- to develop consumer awareness and an education program concerning the presence of microfiber pollution. It requires facilities that are required to prepare or have available a -- a hazardous -- I am told that I should move adoption of the -- of the amendment, and that's what I will do. I move adoption.

## DEPUTY SPEAKER RYAN (139TH):

Thank you, sir. I was -- I thought you'd be getting to it. Will you remark further? Will you remark further? Please proceed, Representative Demicco.

REP. DEMICCO (21ST):

Um.

DEPUTY SPEAKER RYAN (139TH):

Are you finished?

REP. DEMICCO (21ST):

I am finished, yes.

Thank you very much, Mr. Speaker. A few questions to the proponent, if I may?

Please proceed, sir.

#### REP. HARDING (107TH):

Thank you, Mr. Speaker. So, just going on to the amendment, particularly in regards to carp. If the good proponent could explain what has occurred recently in regards to bow fishing in regards to carp and what this particular amendment does to address that?

#### DEPUTY SPEAKER RYAN (139TH):

Thank you, sir. Representative Demicco, can you explain that?

REP. DEMICCO (21ST):

Yes, Mr. Speaker. Recently, regulations were adopted with regards to carp fishing, and there were — it was — the regulations were somewhat resulted in a misunderstanding I guess is the best way to put it between the people who fish for carp with — with bows and — and the anglers in carp fishing, so what this amendment would do is — is say that the commissioner will adopt regulations that would clarify the misunderstanding that occurred recently.

DEPUTY SPEAKER RYAN (139TH):

Thank you, Representative Demicco.
Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker, and thank you to the proponent for the clarification. So, through you Mr. Speaker, if I may, just to clarify. This means that the regulations in regards to fishing carp current will not apply to bow fishing of carp and that it will allow a period of time for bow fisherman to work with the commissioner and discuss regulations for that separately. Is that correct?

Through you, Mr. Speaker.

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

Yes. Thank you, Mr. Speaker. Yes, after the regulations are adopted. That is correct.

DEPUTY SPEAKER RYAN (139TH):

Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker. And, just moving on to the other section of the amendment very quickly.

The other aspect of the bill -- excuse me of the amendment in my understanding is a buy -- buy, protect, sell program. If the good proponent could just quickly give a summary of that?

Through you, Mr. Speaker.

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

Yes. Yes. Thank you, Mr. Speaker. Yes, the buy, protect, sell program under this -- under this amendment would be changed. It would allow the

commissioner to buy agricultural land and then sell it along with development rights to either a municipality or a nonprofit, and then immediately buy it back from the municipality or the nonprofit. What this would do -- it would streamline the time that it would take for landowners to execute such a transaction under the Farmland Protection Program, and most importantly, it's going to allow the state of Connecticut to leverage federally reimbursed conservation money from the -- from the USDA Natural Resources Conservation Service. The -- so this would get us money from the feds in order to effectuate this program.

DEPUTY SPEAKER RYAN (139TH):

Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker, and through you Mr. Speaker, looking at the section 502 of the amendment, my understanding is -- is that this section institutes a task force or a study in regards to microfibers and that this -- this study

would have the clothing and -- and apparel industry involved in that study. Is that summary correct?

Through you, Mr. Speaker.

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

That is correct.

Through you, Mr. Speaker.

DEPUTY SPEAKER RYAN (139TH):

Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker. Also, further understanding is section 503 of the amendment involves a requirement that all those chemical plants who are already required by law to do an update on a periodic basis would have to consider the aspects of shoreline rising or shoreline aspect and update their plan accordingly. Is that true?

Through you, Mr. Speaker.

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

Yes, that is correct, Mr. Speaker. They would have to take that into consideration in the updating of their plans.

REP. HARDING (107TH):

Thank you, Mr. Speaker. And, it's my understanding that the law already requires these facilities to -- to create an updated plan periodically, so this doesn't put another mandate for them to update a plan. This is only when they're updating the plan they have to consider this. Is that correct?

Representative Demicco.

REP. DEMICCO (21ST):

Mr. Speaker, the gentleman has done his homework. That is correct.

DEPUTY SPEAKER RYAN (139TH):

Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker. I didn't do it in school, so it's good I'm doing it here. Thank you. Just quickly, there's another aspect of the bill, if I may -- excuse me, the amendment section 504 involves, to my understanding, a -- a climate change aspect to education. If the good proponent could please explain that?

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

Yes, Mr. Speaker. This -- this part of the amendment would direct the state Board of Education to make available curriculum materials and other materials to assist and encourage local boards of education to -- to -- in their teaching of climate change consistent with the next generation science standards, which has already been adopted about, I believe, it was 3 years ago by the -- by the state Board of Education.

Through you, Mr. Speaker.

DEPUTY SPEAKER RYAN (139TH):

Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker. And, it's my understanding that previously other bills, particularly in regards to climate education was a mandate. It's my understanding that this is no longer a mandate. Is that correct?

Through you, Mr. Speaker.

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

Through you, Mr. Speaker, that is correct.

This is a may, not a shall.

DEPUTY SPEAKER RYAN (139TH):

Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker. I further understand that section 505 of this amendment involves a -- some changes to our Sunday bowhunting laws. If the good proponent could please explain that?

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

Yes, through you Mr. Speaker, as you may know and as the good gentleman knows, currently, bowhunting of deer is allowed on - on Sundays in deer management zones that are -- that are delineated throughout the state of Connecticut. This portion of the -- of the amendment would allow for bowhunting of deer on Sundays throughout that state of Connecticut on private property, specifically with the permission of the private property owner.

Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker. Moving on if I may,
Mr. Speaker, to section 506? Through you, my
understanding is that section 506 of this amendment
is certainly a technical change requested by the
Department of Agriculture to allow us to -- to
collection on potential federal -- federal funds

through simply a name change in the program that the state would participate in. Is that a good summary?

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

Yes, that is correct, Mr. Speaker. The name of the program was changed from the Farm and Ranchland Protection Program to the Agricultural Conservation Easement Program, and by -- by this simple change in this amendment, we are eligible for -- for approximately \$14-million-dollars in federal money, so this is something that really needs to be done, and I'll leave it at that.

Thank you, representative. Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker. And, finally on the last section of the amendment, section 508, this provides a 2-year pilot program that municipalities

can optionally participate in. I think it's
currently one municipality can optionally
participate in through the offices of DEEP, which
would allow them to separate recyclables,
particularly glass and plastics, and other
recyclables. Could the good proponent just quickly
give a summary on that particular program?

DEPUTY SPEAKER RYAN (139TH):

Representative Demicco.

REP. DEMICCO (21ST):

Yes, through you Mr. Speaker, as you may know, glass is probably the biggest problem with regards to the statewide recycling. The attempt here is to create a pilot program for one municipality. They would — the municipality would direct the residents to separate glass from their curbside recycling. The municipality would have to provide a location for that glass to be dropped off at no charge to the residents, and again, this is a pilot program and the commissioner — after — you know — after the 2 years, the commissioner would report back to the

Environment Committee about the efficacy of the program.

DEPUTY SPEAKER RYAN (139TH):

Representative Harding.

REP. HARDING (107TH):

Thank you, Mr. Speaker. So, just quickly in summary this is a combination and a real working group from both democrats and republicans to try to get a good amendment done, and I do support this amendment overall, and I would urge my colleagues to do the same. Thank you, Mr. Speaker.

Thank you, sir. Will you remark further on the amendment before us? Will you remark further on the amendment before us? Representative Buckbee from the 76th, sir.
