## SENATOR FRANTZ (36TH):

Thank you, Madam President. I appreciate that very much. What this bill does -- we get this bill every year because certain municipalities forget to file for their grand list exemptions. And this is no different this year, in 2018. And just briefly, section 501 allows taxpayers in Norwich who have been eligible for certain tax exemptions if they have not missed the deadline to file a claim to receive such exemptions. It also deals with the Town of Derby and a variety of other towns. And this is just really basically a sort of wrote bill that we see every year for those towns who missed that deadline. SENATOR FRANTZ (36TH):

Yes. Madam President, with your permission, we do have an amendment. It's LCO 5867. If the Clerk could possibly call that as well?

THE CHAIR:

Mr. Clerk, will you call that amendment.

CLERK:

LCO No. 5867, Senate "A," offered by Senators Fonfara and Frantz.

THE CHAIR:

Senator Frantz.

## SENATOR FRANTZ (36TH):

Thank you, Madam President. I move adoption of the amendment, waive the reading, and seek leave to summarize.

#### THE CHAIR:

Please -- the motion is on adoption. Will you remark, sir?

#### SENATOR FRANTZ (36TH):

Yes, ma'am. Thank you so much. I appreciate that. So, the amendment does make some changes to the underlying bill which has to do with the estate and gift tax phase-out period and the amounts over a longer period of time than originally expected — originally predict — called for in the underlying bill into a lower amount. So, the amendment doesn't affect the other parts of the bill. So, let me tell you about those for a little bit. This, once again, is an attempt by the DRS as well as the executive branch to soften the blow of the limitation on the SALT deduction that a lot of Connecticut taxpayers are making to the federal government in terms of their tax credit at the federal level.

So, what this does in essence, there are two larger parts of this bill. What happens is Connecticut will, if this bill passes and the amendment passes, will establish a tax at the entity level of 6.99 percent, assuming you're in the highest marginal tax bracket, and then what that does is it reduces your taxable income in the State of Connecticut. There's another -- assuming you're in the highest marginal

tax bracket, another tax imposed of 6.99 percent, but you get a credit back for that amount - 6.99 percent. So, net-net end of the day, even though you're not made whole, you do get the federal tax deduction. You do get a state tax credit and you make out at maybe 85 percent, 90 percent of where you would be as of, you know, three, four, five months ago before the federal tax plan was passed.

So that's a good thing and I highly, highly support that. I know it's gonna be challenged by the federal authorities, by the IRS in particular, but we have to try.

The second part of the bill is a last-minute [inaudible - 00:03:09] to providing property tax credit to eligible taxpayers who make voluntary payments to municipal -- municipally-approved organizations that will serve people in need of social services or education, or something like that. And therefore, you, the taxpayer, get a federal tax deduction like you would've ordinarily for making that contribution directly to a citizens in need account, for example, as Senator Suzio thought of this well before we knew who our current president was gonna be. So, this I see as another really good part of this bill. And I know it's gonna be challenged by the IRS, but nonetheless, you have to try. You have to try to make these policies work and I think it's worth supporting.

And that's essentially it. There are a few other small parts that are more technical, green -- having to do with the Green Bank, etcetera, etcetera, and the DECD having to study best practices for marketing benefits of qualified opportunities on, etcetera, etcetera. But that's essentially it. And
