The House reconvened at 8:50 o'clock p.m., Deputy Speaker Ryan in the Chair.

DEPUTY SPEAKER RYAN (139TH):

[Gavel] The Chamber will come back into session and we will stand-at-ease.

The Chamber will come back to order [Gavel]. Are there any announcements or introductions? Hearing none, will the Clerk please call Calendar No. 497.

On Page 59, Calendar 497, Substitute House Bill

No. 7378, AN ACT CONCERNING NEGLIGENT HOMICIDE WITH

A MOTOR VEHICLE AND ILLEGAL RACING. Favorable

Report of the Joint Standing Committee on Judiciary.

DEPUTY SPEAKER RYAN (139TH):

Representative Stafstrom from Bridgeport, you have the floor.

REP. STAFSTROM (129TH):

CLERK:

Thank you, Mr. Speaker. Mr. Speaker, I move for Acceptance of the Joint Committee's Favorable Report and Passage of the Bill.

DEPUTY SPEAKER RYAN (139TH):

The question is Acceptance of the Joint

Committee's Favorable Report and Passage of the

Bill. Representative Stafstrom, you have the floor.

REP. STAFSTROM (129TH):

Thank you, Mr. Speaker. Mr. Speaker, the Bill before us comes out of the Judiciary Committee and received unanimous support of the Committee at which the Committee was struck by the testimony of the family of a Veteran by the name of Shalymar who was killed in a motor vehicle accident up in Shelton as a result of illegal street racing. Mr. Speaker, illegal street racing both in our cities and on some of our suburban and rural roads has become an increasing problem in the State of Connecticut. Folks who seem to find it fun to get out, get behind the wheel, drive as fast as they can racing someone else posing significant risk of injury or death to other motorists or pedestrians. Mr. Speaker, in looking at our current penalties for negligent homicide with a motor vehicle and illegal street racing it was certainly the belief of the Committee

that our current penalties are too low, the Bill before us seeks to increase those penalties and I would ask for the Chamber's support.

DEPUTY SPEAKER RYAN (139TH):

Thank you, Representative. Representative Rebimbas of the 70th, ma'am you have the floor. REP. REBIMBAS (70TH):

Thank you, Mr. Speaker. Mr. Speaker, I rise in support of the proposal before us and as the good Chairman had indicated it did come out of the Judiciary Committee unanimously. Unfortunately this is one of those incidences that this Bill comes before us as a result of a very, very tragic death that occurred as a result of illegal racing. So just a few questions.

Through you, Mr. Speaker.

To the good Chairman.

DEPUTY SPEAKER RYAN (139TH):

Please proceed.

REP. REBIMBAS (70TH):

Thank you, Mr. Speaker. If the good Chairman can highlight and I know that in his introduction he

had indicated that there were fines that were being increased as a result of the proposal before us, if he can highlight what those fines are?

Through you, Mr. Speaker.

DEPUTY SPEAKER RYAN (139TH):

Representative Stafstrom.

REP. STAFSTROM (129TH):

Thank you, Mr. Speaker. Mr. Speaker, under current law negligent operation of a motor vehicle that results in a homicide has two classifications whether that motor vehicle is a commercial vehicle or not. Under present law if the motor vehicle is not a commercial vehicle then negligent operation is punishable by fine up to \$1,000 dollars and up to six months in prison. If the motor vehicle is a commercial motor vehicle then under current law that offense is punishable by a fine of up to \$250,000 dollars and six months in prison. Under the Bill we would increase and conform those two penalties and negligent operation of any motor vehicle would be punishable by a fine of up to \$3,500 and up to three years in prison or both.

REP. REBIMBAS (70TH):

Thank you, Mr. Speaker.

If the good Chairman knows why do we have a distinction between commercial vehicles versus regular vehicles.

REP. STAFSTROM (129TH):

Through you, Mr. Speaker.

I think it was, certainly I'm speculating as to the original drafters of this original legislation some years ago, certainly prior to my service in the legislature but I can speculate that folks thought that negligent operation with a commercial vehicle was somehow more risky to public safety than a noncommercial vehicle. The reason that we are moving to conform these two penalties is certainly

negligent homicide is negligent homicide and whether you were driving a truck or driving a car in a negligent manner that results in a homicide you should be punished accordingly.

Representative Rebimbas.

REP. REBIMBAS (70TH):

Thank you, Mr. Speaker.

Are these fines criminal or civil?

These are the criminal penalties, certainly someone who is operating a motor vehicle in a negligent manner or that causes personal injury likely would also be subject to a civil lawsuit.

I apologize, I actually had only highlighted the fines that increase under the Bill for negligent operation of a motor vehicle. The fines under this Bill would also increase for the offense of driving a motor vehicle on a public road for purposes of betting, racing or making a speed record. Those fines would also increase. Under the Bill the maximum fine for first offense would be \$150 dollars and would be \$300 dollars for any subsequent

They are punitive in nature and as I indicated the rationale for the Bill is having looked at having had this issue brought to our attention by certainly some powerful testimony at the Committee level we thought it was appropriate to raise the fines for these two particular offenses under our law.

Many times we have certain penalties that may depending on the perpetrators age may have different

tiers of fines or different tiers of punishment does exist in this in this proposal anywhere?

I believe there is only one tier of fines but of course the fines are the maximum fines, the court has discretion to issue a fine that is less than the maximum amount prescribed.

And often times there's discussion regarding the developmental age of a juvenile versus an adult. In this case are we making any type of differentiations, considerations for maybe a juvenile under the age of 18 that may be obviously facing the negligent homicide charge versus an adult

in their 50s?

The age of majority remains unchanged under this Bill pursuant to our existing Juvenile Justice Statute.

And just to clarify my question a little bit better, is there differentiating treatment. So are we treating the juveniles, minors any different than an adult?

That is certainly, the folks that were incarcerated are on probation would be a small subset of those who were convicted and that being a small subset of those who were charged with the offenses we're speaking with here today.

I want to take the opportunity to thank the good Chairman for all of his responses and I do as I indicated rise in support of the proposal before us. Again unfortunately it comes from a very tragic story and it was one of which many of us from the Judiciary Committee hearing through the Public Hearing from the very family unfortunately to have lost their loved one as a result of street racing. It was something that everyone felt the duty and responsibility to want to do. Again we can only hope that maybe this increase in fine may be a deterrent, unfortunately I think many times when we are dealing with juveniles that may not even be something that is in their mind sadly. One would almost think that anytime you hear of a death as a

result of this reckless behavior that in and of itself would be a deterrent. But again hopefully through this there could be some public education and public announcements and people learn from other people's mistakes in that regard. So I do rise in support of legislation before us and certainly again I think, you know, we do have a responsibility to try to curtail any type of criminal action whenever we can and not just the act of racing but I think it has been a practice sadly of street racing associated with the stolen vehicle aspect of things too. So hopefully the message will get out that this is something that should be avoided, not just for the fines but the mere fact that this can cause someone's life and the impact that is felt on that for a family is forever. So, Mr. Speaker I rise in support of the proposal before us.

DEPUTY SPEAKER RYAN (139TH):

This family of the individual happens to reside in my district and of course it was a very, very strong loss for us and I believe this is a measured approach to address a very, very serious issue which hopefully we will see a decrease in these fatalities. So I also want to mention that it is important to thank the late Representative Santiago and also Representative Candelora who are not here but they were strong advocates of this Bill from the start. So, thank you, Mr. Speaker.

This is a young woman whose life was cut unfortunately too short and she served our country proudly and secondly, our good friend and late colleague, Representative Ezequiel Santiago this is one of the Bills at the beginning of session that he came to me and said, "Chris would you support me on this" and never in a million years that I think that I would be testifying on this Bill because he wouldn't be there. So I am just merely standing up and speaking up for Ezequiel since he is not here physically but his work lives through us and is going to continue on. Thank you, Mr. Speaker.

down, as Mr. Pelka [laughter] said, down 17 percent over ten years, 43 percent over 20, and that juvenile participation has remained relatively constant.

Sensationalism makes it seem like Connecticut is dealing with a particularly violent -- virulent strain of this epidemic. Data tells us that a recent uptick over the last few years is in line with national trends.

Public-facing comments about recidivists and repeat offenders that falsely attribute juvenile crime to Raise the Age Reforms and/or the closing of CJTS lead to bills prompting the transfer of juveniles to adult court. I'm almost done. Data shows that putting juveniles in adult prison is cruel and dangerous, deprives them of important education and rehabilitation opportunities, cost far more than upstream and downstream diversion and intervention programs, and that the more time juveniles spend in confinement the more likely they are to reoffend, all this and it doesn't even help public safety.

juvenile and youth -- youthful offender proceedings as they are now.

For the last section of -- I am opposed to Section 2 of raised <u>Bill 7389</u>, which should come as no surprise, as I said on JJPOC, and voted against it. But it would have a blanket on prohibition against any person under 18 being detained and incarcerated in any correctional facility operated by the DOC.

Right now, crime victims may register to receive notification of an offender's incarceration status through the Victim Services Unit. Victims can receive notice of their release or notice or anything going on that they -- that may impact their decision-making. It allows them to address safety concerns and other issues. So, you know, the sad reality is that some juveniles do commit murder and sexual assault, and we need to have a way to manage that, and the language seems to not do that.

And the finale thing, which is not for me, but I just want to know for the record that a client, Diane Wilczewski submitted written testimony to you in support of raised Bill 7378 regarding negligent homicide with a motor vehicle. She lost her child in 2015 in a car accident, and the person only get nine months for negligent -- no, only spent 30 days in jail and a short 18 months on probation. And he basically, not only had a medical condition and went and drove and the -- and hit her child and killed her. So, she's in support of that bill which would address that matter.

help us get through the list that way. Representatives, the floor is yours.

REP. CANDELARIA (95TH): Good afternoon, Chairman Stafstrom, Senator Winfield, Senator Kissel, Representative members, and members of the Committee. Thank you for the opportunity to come before you and testify in support of Bill 7378. This is a Bill that initially was introduced as proposed Bill 6720. And the reason I mention that, because I want to recognize that Representative Ezequiel Santiago was critical in working with me to submit this Bill before you. So, I want to take the opportunity to acknowledge that.

But I don't want to go into details of the Bill. You have the Bill before. I submitted written testimony. Because I want to give the opportunity to the parents to say a few words and you can hear their testimony. And then, I will be available for any questions you may have. So, I'm going to yield this time right now to Representative Rosario. Thank you.

REP. ROSARIO (128TH): Good afternoon,
Chairman Stafstrom, Chairman Winfield, Members of
the Judiciary Committee. I, too, am here in support
of HB 7378, AN ACT CONCERNING NEGLIGENT HOMICIDE
WITH A MOTOR VEHICLE AND ILLEGAL RACING. My friend,
and all our friend and dear colleague,
Representative Ezequiel Santiago was very
instrumental in putting this forward. And I am here
on his behalf, along with the advocates that he
worked closely to make sure families get justice
here in the state of Connecticut. So, at this time
I would like to yield my time to the parents of

Shalymar Herrera, who were affected by this tragedy. Thank you.

LIZA HERRERA: Good afternoon, Legislator. It —
it's a pleasure, an honor to come before you today.
My name is Liza Herrera. And I am here to support
Bill 7378. I lost my daughter on April 8, 2018, two
hours after my son and I had spent the entire
morning with her. She was everything to us. She
had an amazing, humble, brave heart. Words cannot
describe the impact she put in — she put on this
very earth.

Shalymar passed away in a horrific car accident due to -- due to negligent street racing. The crash took -- the crash not only took the life of our daughter; it took the life of other passengers that include Brianna Torres and her unborn daughter Luna who was due to be in a month. I often think, if the laws had been stricter with regards with street racing, the driver of the two cars involved might have thought twice before they decide to race with -- without regards to their life, the passenger or passerby that day.

My daughter was a solider of the United States Army who was willing to put her life on the line to protect your freedom and mine. She was preparing to go to college to become a veterinarian. Shalymar's hopes -- hopes and dreams were all about a positive difference in the lives of others.

I will never see my daughter again grow to be an amazing woman. I can never listen -- I can never listen to her voice again. And I will never see her care for my son again the way that she used to. We want nothing more to see her prosper. While nothing will ever bring back our daughter, we have decided

to turn over tragedy into something positive for others to help prevent this tragedy from happening to other families.

We want to see this Bill pass because it will increase the penalties for those who commit crimes like the one that killed our daughter. The passing of this Bill is extremely important to us. We cannot make this positive change in Connecticut laws happen without -- without your help. So, now ask that you please help us lower the likelihood of this happening to other family. We kindly thank you for your time and your consideration.

REP. STAFSTROM (129TH): Thank you, ma'am. Thank you. Thank you so much for being here, for presenting your story, for the sacrifice of your daughter and her willingness to serve our country, you know. And I really want to thank the Representatives for bringing this to us. This is a huge problem on the streets, particularly in our cities, of street racing.

For whatever reason, folks have decided that they're going to get behind a wheel, they're gonna try to drive as fast as they can, and get kicks out of it. And it's not happenin', I -- at least I don't -- maybe it is, but -- but where it's particularly problematic is on streets of our cities in places where folks live close together, where they're walking from one shop to the next, where they're walking to the grocery store, walking home, and -- and tryin' to cross streets. You know, they're going down narrow roads with cars parked on both sides of it. And it -- I see it quite frequently.

I mean, it's not that uncommon for me to leave here at some late hour of the night, get home, get off on

Exit 25 on Fairfield Avenue in Bridgeport, and, you know, it's a very narrow road, it's traffic on one side, the lanes are a little narrower than they should be, and -- and you constantly see people, you know, gunnin' the engine and -- and racing. And it is -- it is remarkable that we don't see more tragedies like this.

And, you know, I -- I really hope that this legislature will take to heart sort of the -- the concerns you've brought to us. And unfortunately, sometimes it takes horrible incidents around here for us to -- us to take action. But I certainly hope this is one instance where -- where we do that. So, thank you so much for being with us. Vice Chairman Blumenthal.

REP. BLUMENTHAL (147TH): Thank you, Mr. Chair. And Representative DiMassa, unfortunately couldn't be here right now because he had business back in the District, but he wanted us to read this statement.

Representative DiMassa had business back in the District, but he wanted to extend his full support on this <u>Bill HB 7378</u> and thank Jesus and Liza for their -- for advocating for stricter penalties so that no family has to endure the tragic events that unfolded last year that took the life of their beloved daughter. He extends his deepest sympathy to the Herrera family and his hopes that this legislation will stand as a testament to the legacy of their daughter, Shalymar.

And I just wanted to extend my sympathies, as well, and thank you for your activism on this issue. And hopefully, that will lead to a situation where other families will not have to experience the terrible tragedy that you have. Senator Kissel.

SENATOR KISSEL (7TH): Thank you very much, Chairman Stafstrom. To the two parents, you're incredibly brave. It's probably the -- the loneliest club in the world, are parents that have lost one of their children, and it's just a group that no one wants to be a part of. And I've met various parents who have lost children, it's just never good.

You're doing something very positive here. I will be supportive of this measure. I thank the two Representatives that are here with us and the late Representative Santiago who was a champion in this earlier. And your show of support, all of you, makes a difference. A lot of times back -- you talk to people, I talk to my constituents, and sometimes you'll get some folks that are jaded and they say, oh, well, you're gonna do whatever you want to do in Hartford or my voice doesn't matter or my vote doesn't matter. Well, that's wrong. Your voice, your presence here this afternoon has a tremendous impact. Not only visibly but you're championing a cause and trying to turn something good out of a great tragedy.

And so, I just want to thank you for being so brave to come before this Committee and express yourself so articulately on behalf of your daughter. And I'm sure she's in heaven looking down and thanking for her service to our country. And I know that my sentiments are shared by many others in the legislature, as well. So, thank you all for coming here.

LIZA HERRERA: Thank you.

SENATOR KISSEL (7TH): Thank you, Mr. Chair.

REP. STAFSTROM (129TH): Further questions or comments from the Committee? Representative Dubitsky, followed by Representative Porter.

REP. DUBITSKY (47TH): Thank you, Mr. Chairman. And thank you for coming in here to talk about this. I -- you know, my understanding is this is a -- a big problem in some areas. I, you know, have to admit that it -- it does not appear to be a problem where I am out in the -- in the -- the more rural areas, but clearly it's a problem in your -- in your area. And I want to do everything I can to help you solve that problem.

To that end, I -- I ask -- like, a -- a lot of people come to me with various Bills seeking to increase the penalty for something, thinking that increasing the penalty will eliminate or reduce the problem. In some instances it does, in some instances it doesn't. So, what I'm -- what I would ask you is, do you -- are -- are you aware of any instances where somebody has been caught and arrested, and because of a low penalty, has done it again? And the reason why I ask is because, you know, and -- and I'm -- I'm gonna support this Bill, but I -- I -- I'm -- I'm wondering if there -- if we're -- we may be missing some enforcement end of this, and that simply raising the penalty may not have the effect that you're looking for. So, have you -- are -- are you aware of any enforcement issues with regard to street racing?

JESUS HERRERA: My name is Jesus Herrera. I'm Shalymar's father. The police told us, you know, they — they give a lot of citations for stealing, for illegal racing. The problem is because they are so low, the people just going to keep doin' it

because nobody wants a \$75-dollar ticket for illegal racing, it's cheaper than going to the racing track. You go to a racing track; you're going to pay \$150 dollars. You go in the street, if you get caught, you pay only \$75 dollars, if the police decide to give you a ticket or to give you a break. know -- we don't only want to increase the penalties, because we want to try to do something to prevent to get there. And just increasing the penalties will make people think -- think twice to do something. If you say, hey, if you -- you do illegal racing, you're going to get three months in jail and \$5,000 dollars, they're going to think it twice and say, hey, you just gonna get \$75 dollars. So, you know what, pay the \$75 dollars and I race some more again.

We also would like to modify the system in Motor Vehicle Department where they teach the new drivers what are the consequence for illegal racing, and not only for penalties, as far as the consequence for people that die, for people that get hurt. And -and it's not only the people that get hurt and die, it's the family that stay behind suffering for life because whole life changes, and there's no coming back. And especially for the parents, it's hard to keep moving forward. Like people say, you know, be strong, move forward. Life is completely different I have to keep it strong and be positive, keep working every day because I have another son that he also deserve to have the same father, to have the same joys that her -- his sister had. You know, I have to keep going and skating with him. It's hard because she was always dancing with me. Now, it's only him. It's so many memories that sometime people say, memories is going to bring you joy to

your heart. It's -- it's hurt. It's memories that you can't repeat again. It's memories that hit you every second, everywhere that you go, everything that you do. You want to buy something for her, she's not there. You want to share something with her, she's not there.

So, we not only have to try to increase the penalties to make those people think a little better. But we also have to teach the new drivers and deliver the message out there what are the consequence and the suffering that their families are going to be having. It's -- it's not only be to punish someone, it's about to give they vocation before they do something, what's going to happen, look -- how the family suffer. Who -- and -- and then we're gonna engage the penalties? But you don't have excuse to say, I didn't know that, you know. So, let's try to implement this in the Motor Vehicle Department the same way they deal with alcohol. So, now the people that get alcohol, of course they have an excuse to say, I didn't know that because they have to take it in the test.

REP. DUBITSKY (47TH): Clearly, you have more strength than -- than many to be able to -- to come here and -- and advocate after what's happened. And you know, certainly educating people before this happens is an important aspect of it. Do -- do you know that people do regularly get cited for the \$75 dollars? And if so, do they -- do they pay it?

JESUS HERRERA: Well, I don't have sort of information to respond to that.

REP. DUBITSKY (47TH): Okay.

JESUS HERRERA: That would be, you know, we would have to do a deep search for it. And so, I can't really, you know, answer that question with -- with exact data.

REP. DUBITSKY (47TH): Okay. Well, as we move forward with this, there's one thing you may wanna --

JESUS HERRERA: Get.

REP. DUBITSKY (47TH): -- also look at it is, you know, if people aren't paying the \$75 dollars, they're probably not going to pay \$1,000 dollars or \$3,000 dollars, because maybe the police won't even issue the citations --

JESUS HERRERA: Exactly.

REP. DUBITSKY (47TH): -- when they get that high. So, you know, enforcement of these fines is a key element. And if you -- you know, if -- if there's no enforcement, you could -- you can impose the death penalty and it won't help.

JESUS HERRERA: Yeah.

REP. DUBITSKY (47TH): So, you know, we -- as -- as we -- as we move forward with this, you know, perhaps you can feed us some information on anything that you know, and -- you know, and perhaps the -- the good Representatives can -- can help that out. Because, you know, it -- it -- just increasing the penalty may not -- may actually make it worse, because maybe the police will stop giving citations if they're so high. So, you know, I -- I don't know that. I'm just -- you know, I'm -- I'm just --

JESUS HERRERA: Yeah.

REP. DUBITSKY (47TH): -- throwing out hypotheticals. So, you know, it's certainly something that -- that we all want to look at is how do we get people to actually stop doing it and not just, you know, increase the penalty after they've already done it.

LIZA HERRERA: I --

JESUS HERRERA: Definitely we're gonna do some searching.

LIZA HERRERA: I'm sorry, I want to say something. I think also it's about for teenagers, we need more to teach them more like -- they need come more like to classes. We need to like -- that's why I -- I think if we increase this penalty, we could make the teenagers think twice when they are in the car and they have people in the car and -- and they, you know, they -- to make more responsible. I teach my daughter that when she make a mistake, she was responsible for -- for what she did. And -- and I think we should teach the teenagers like to -- make consideration with people in the car and people outside that they put in dangers.

REP. DUBITSKY (47TH): You know, I -- I -- I certainly understand what you're saying and -- and, you know, I'm -- I'm certainly willing to help you in any way I can. Because obviously this is a -- a big problem in your area. And, you know, if there -- if there's anything other than what's in the Bill that you think needs to be added, I'm certainly willing to work with you on that, as well.

JESUS HERRERA: I appreciate that.

REP. DUBITSKY (47TH): Thank you.

REP. ROSARIO (128TH): If I -- if I may through the Chair --

REP. STRAFSTROM (129TH): Certainly.

REP. ROSARIO (128TH): That - that's information that I - I'll be more than glad to have my staff look up and provide to the Committee as a whole.

REP. DUBITSKY (47TH): All right. I appreciate that.

REP. CANDELARIA (95TH): If I may, Mr. Chairman. I -- I think one thing that -- that needs to be noted in -- in this change of the language is that when you look at evasion of responsibility in operating a -- a motor vehicle which -- talks about the illegal racing, right now it's \$75 dollars. So, what the Bill does is increase it to \$150 dollars. But not only that, it also mandates an eight-hour reckless aggressive driving. And under any subsequent situations, what it does, it raises that to \$300 dollars and also suspends the -- the individual's driver's license. So, there is some -a little -- a lot more. So, you know, once you have to go through all those processes, you'll think twice, right. I think that -- that what we thought out in the language of the Bill is how do we deter it from happening again. And your first time, we -we understand that -- that can happen because we talk about -- some of them may be even teenagers, young adults. But subsequent offenses, you see that as a stronger penalty in the sense that you have to go to class, plus if you don't go, we'll suspend your driver's license, as well.

REP. DUBITSKY (47TH): And -- and again, that -- that would -- that would hinge on whether or not a citation was issued --

REP. CANDELARIA (95TH): Right.

REP. DUBITSKY (47TH): -- and whether or not the person is actually found guilty. This would be the penalty after that. So, you know, we -- we also want to make sure that those steps fall into line as well, and that people are cited -- you know, when they -- when they should be as opposed to being let off. You know, if you make the penalty too high, perhaps the police will not be issuing as many citations.

REP. CANDELARIA (95TH): That's right.

REP. DUBITSKY (47TH): That's all something to -- to think about. And I -- I appreciate you coming in and talking about this. It's obviously an important issue. Thank you.

REP. STAFSTROM (129TH): Representative, I -Representative, I appreciate you raising this issue,
Representative Dubitsky, as well. Because I do
think this is a two-part problem. One part is
certainly the penalties and the like. But there is
an enforcement mechanism to this as well. And -and, you know, obviously as we discussed this
morning with some other Bills, you know, there -there's a holistic approach to things. And
sometimes legislation would pass maybe a positive
step in the right direction, but it might not solve
all the issues.

And, you know, unfortunately this is one of those instances, I think, where this is a -- this is a very positive step forward. It's a step in the

right direction. But we continue to see, especially in our cities, a lack of resources, you know. Our cities in the state have some of the highest property taxes and the highest property tax burdens anywhere, anywhere in the nation, but continue to --because of their size and because of a lack of economic opportunity, continue to struggle with a lack of resources, be that in our schools and in our police departments.

I mean, I know in Bridgeport, for example and Representative Rosario, I'll give you a chance to comment, we don't have traffic enforcement after 5:00 o'clock p.m. -- after 4:00 o'clock p.m. in Bridgeport. They don't -- the -- the cops can't afford to do it. They respond to the calls, if they get a call. But there are no officers out there paroling the streets looking for traffic violations, because even with 440 police officers on the force, there isn't the manpower. So, they're not out there issuing speeding tickets. They're not out there issuing tickets for folks rolling through stop signs. We don't have the manpower. And we have a mill rate of 55. Representative Rosario.

REP. ROSARIO (128TH): Sure. If I -- if I may add, and -- and I could speak on this -- on this issue twofold. One, obviously representing the city of Bridgeport, but I actually work for the city of Shelton, where this tragedy unfortunately took place. And same issues that are happening in Bridgeport are happening in -- in the cities and towns across the state. We don't have enough resources for traffic enforcement and -- and other issues, with that being said. So, my -- I -- I totally agree and it's a twofold problem.

REP. STAFSTROM (129TH): Further questions or comments from the Committee? Representative Porter.

REP. PORTER (94TH): No questions. Just a comment. First and foremost, my heart goes out to -- to both of you, all of you. There's a solidarity that cannot be denied in this room right now. This space is -- it's -- it's big, but the love -- the loss, I cannot imagine, but I do feel your pain. And I'm so very sorry that you have to be here to testify on these grounds. But I applaud you for having intestinal fortitude to sit before this Committee and share your story and share your pain.

And I am 150 percent behind this Bill. And yes, we need to address it holistically. But you -- one bite at a time, one step at a time. And this is definitely a step in the right direction.

And I know your pretty girl is looking down and very proud of what you all are here today doin' on behalf of her and anyone else that may be, you know, susceptible to this — this kind of accident. And it is about prevention, you know. It was tragic. But if we can do anything to stop another family in the state of Connecticut from experiencin' what you will have to experience for the rest of your life, because you're right, every single day is a struggle. And my prayer for you is that every day is gets a little easier. That's my prayer. And just know that my — my prayers and thoughts are with you especially, for all of you, all of those that loved her, her family, her friends that I am praying for you all.

JESUS HERRERA: Thank you.

Thank you for being here today. Thank you, Mr. Chair.

REP. STAFSTROM (129TH): Thank you. Further questions or comments from the Committee? Representative Rebimbas.

REP. REBIMBAS (70TH): Thank you, Mr. Chairman and good afternoon. I just want to take this opportunity, again, also to thank you for your daughter's service to our country. Because obviously, she was doing something that she knew was giving up her time and dedication and probably never had a thought that this is the way that she would have lost her life. So, I thank her very much for what she's done for the country. I think -- I thank you and everyone who's here taking the time to advocate, turning this horrific experience in your life into something we hope will stop the next accident in that regard.

So, and I do want to point out and I think the Representatives have done a wonderful job in indicating this is not just an inner-city issue. They actually look to the rural -- rural areas to open -- open streets and no traffic and think that it's safe to do. It's just as tragic. I think people forget that driving is a privilege, it's not a right, and it's one they should be taking very highly.

So, when it's street racing or the other practices, stealing vehicles and then racing those vehicles, because they're the faster ones or your, you know, a -- a bigger, badder person because now it's a stolen vehicle, anything can cause the loss of a life. Someone innocently crossing the street, someone innocently coming out of their vehicle on

the side of the rode, another vehicle coming who had the right of way. And then just the mere fact of losing control. Like this shouldn't even be an idea that enters into these peoples' minds to think of even racing or stealing someone's car and -- and having a chase, shouldn't even be.

So, I thank you for taking the opportunity to be here. I support the educational component. These people should be doing community service and speaking on panels in front of other kids, explaining what exactly happened that caused a tragedy in somebody else's life.

So, I fully support and, you know what, it's a step in the right direction, but I hope it's a step that we'll see all the way through and the Governor signing into law. So, you've got certainly my commitment, and it sounds like you've got many other people who are committed to this. So, I look forward to seeing this through with you.

JESUS HERRERA: Thank you very much. Thank you.

REP. REBIMBAS (70TH): Thank you, Mr. Chairman.

REP. STAFSTROM (129TH): Thank you madam. Or I could just move for a Consent Calendar to be opened. [laughter] Further questions or comments from the Committee? Seeing none, thank you guys for being here.

JESUS HERRERA: Thank you.

REP. STAFSTROM (129TH): Thank all of you.

JESUS HERRERA: Thank you so much.

LIZA HERRERA: Thank you so much.

JESUS HERRERA: It's okay.

REP. STAFSTROM (129TH): All right. So, as I mentioned, we're gonna continue to go through the list. If there are folks as part of this group or other groups who still want to testify, you can. If you don't, when your name is called, just give me a little nod, and we can -- we can move along. And I think there's a couple of other groups that want to come up together as well on other Bills.

Next on my list, I have Marilyn Bergis. Marilyn Bergis? Okay. Sean Oppenheimer? Sean Oppenheimer is all good? Ernestine Holloway? Ernestine Holloway? Gone. Brittany Moore? Brittany Moore? She gone? Sheila Oppenheimer?

SEAN OPPENHEIMER: She's going to go with me.

REP. STRAFSTROM (129TH): Okay. You guys want to come up? Oh, come on up.

SEAN OPPENHEIMER: All right. Do you wanna go?

SHEILA OPPENHEIMER: You go first.

SEAN OPPENHEIMER: I can go? All right.

Mr. Chairman, members of the Committee, thank you for being here today to listen to my testimony on this Bill. I don't think there are any more words that I could say that will -- that -- that will make any more of a point than what my friend's, Shalymar's parents, just said. But I do want to emphasize how much I support this Bill, because not only does this increase the penalties to make sure that offenders of these laws pay -- pay a price for what they did, it's not -- the penalties aren't always about preventing, it's -- it's about making sure that people don't do the crime again. But also, this Bill adds an education requirement. So, each offense, the offenders have to go through a

reckless aggressive driving class to make sure that they can reflect on their actions. That will make sure that they're a safer driver. They'll return to the roads a safer driver. And it'll decrease the risks that what happened to our community, the communities in Bridgeport, West Haven, Aquadilla, Puerto Rico, where she was from and now lie -- lies in eternal rest, make sure that what happened to us doesn't happen to another community. That's -- that's why we're here. That's why we're supporting this Bill.

Shalymar was my junior prom date. That was a really fun night. Yeah, she -- she was an amazing friend. I can't emphasize how much her smile could brighten up anyone's day or just how she was always there for everyone. She was there for us, she was there for her family, she was there for her country. And we're hoping, as I'm -- we've heard a lot of support, all of you will be there for her in passing this Bill. Mom?

SHEILA OPPENHEIMER: I'd also like to add that there were two others, of course, who died as well, a 23-year-old woman named Briana Torres, pregnant with a baby girl. Her baby shower was the night before Briana died, and despite the best efforts of first responders and medical personnel, the baby died as well. Her name was Luna.

And again, this tragedy occurred in the context of illegal street racing. And somehow on the night of April 8th, the drivers of these two cars thought it was a good idea. And now we are left without precious Shalymar, Briana, and Luna. Thank you for your support. And thank you so much for your comments and feedback for the family.

REP. STAFSTROM (129TH): Thank you, both. Questions from the Committee? If not, I just want to thank you both for being with us. Thanks for your advocacy, and we're so sorry for your loss.

SEAN OPPENHEIMER: Thank you.

SHEILA OPPENHEIMER: Thank you.

REP. STAFSTROM (129TH): Inez Pegais. Maybe we can get somebody who's down there just to help move the mic. Okay, grab -- all right, there you go.

INEZ PEGAIS: My name is Inez Pegais. I represent a Hartford community group Greater House of African-American Alliance. We've been meeting for the last 25 years on pressing community issues. So, here we are. First, please excuse the remarks that they don't agree with any updated version of the Sometimes a community is the last to receive the latest version of whatever goes on in this building. Our group supports SB 880. I think that's the number, especially the collection of data such as the zip code of the defendant. Crimes in Hartford are -- crimes are perpetrated in Hartford by people who don't live in Hartford. We like the zip codes. Primary language of the defendant and the plea bargains offered the defendant or the person who they believe committed the crime.

We also support the pilot program, the suggested pilot program where individuals will have the option, I guess it will be an option, of representation at parole revocation hearings.

And finally, we noted that only two percent of the hearings held for modification of sentences are awarded, two percent, forcing any reasonable person to acknowledge that the current procedure is not

REP. STAFSTROM (129TH): All right. Next up, hailing from the great city of Bridgeport, Albert Benejan. Come on up, my friend.

ALBERT BENEJAN: Hello everyone. My name is Albert Benejan. I'm one of the PTSO presidents from Bssick High School community leader from Bridgeport. I'm here to support Bill 738. Shalymar Herrera was my -- my niece. Imelissu [phonetic] is my sister. I'm sorry. We're going through a lot of things. And we need to have justice for only -- not only for my niece, Shalymar Herrera, for Briana, and the baby Luna.

It's not fair that we have people on the street that are not responsible. My mother had two kids, me and my sister next to me. My sister had two kids. nephew is here and my sister's gone -- my niece is gone. She served for the -- for the United States. She was -- I was very proud. The date of birthday, June 28, 2018, I went to the court to see one of the persons who was driving the car that was not responsible. That day was the first day I don't have my niece tell me, Happy Birthday, Uncle. would never forget April 8, 2018 at 9:47 p.m. when my sister called me and told me my niece was gone. I said, where -- where she's gone? She said she have a car accident. She died. My mother had four grandkids, three boys and she was the -- the princess of the family. Now, she's gone. So, like I said before, I'm here to support and help to build Bill 738. And you know, this is my only sister I have, we all together, we are family, and we're here to work together. I told you in the beginning, and I hope everyone understand. Thank you so much for everything.

HB 7378

REP. STAFSTROM (129TH): Thank you, Albert. And we certainly do understand. And I just want to publicly thank you, not just for your advocacy on this Bill, but your fight day in and day out to improve the lives of folks in the west end and the south end of Bridgeport, in particular, and — and folks who often need a little bit of help and — and need somebody to give them a hand. And you're the kind of guy who would give 'em the shirt off their back if they asked for it. So, I — I appreciate you being here and spending the day with us.

ALBERT BENEJAN: Thank you for your time.

REP. STAFSTROM (129TH): Next up is Romelo Goss. Okay. And I know we've got a whole group of folks who signed up. They're all gonna come up, so we're gonna give them a little -- a little leeway on the time and -- we just need you, if you guys could all just identify yourselves for the record quickly so that we've got that for the Clerk, that would be helpful.

VAUGHN THOMAS: All right. My name is Vaughn Thomas.

ROMELO GOSS: And my name is Romelo Goss. I'm from Bridgeport, CT. I'd like to thank you.

TIANA KRAUS: I'm Tiana Kraus.

ROMELO GOSS: I'd like to thank you for this time to -- you want me closer? All right. I'm in favor of <u>HB 7389</u> because I feel we need to remove youth from adult prisons. I feel we are hurtin' them more than we're helping them.

Sittin' at the police station until the next morning to get my bond set, was already traumatizing. Being

JULISSA TORRES: Good afternoon, legislatures. name is Julissa Torres. I am here for the proposed <u>Bill 7378</u>. My daughter was Briana Torres. eight months pregnant. The day before the accident, we just celebrated her baby shower. On this given day, she called me, she told me she was on her way to me. I got this bad habit of looking at the time every time my kids leave my home. I looked at the time, it was 6:37. And I waited. All she asked me was, "Mommy, I want some potato salad." And I told her, "I got the water boiling." I waited. Next thing you know, everything -- a knock on the door, so I run to my door thinking it was my daughter and it was the cops saying that there was an accident, that I needed to go to the hospital. Letting you know, that I did go, sure. I sure went to the hospital. I called my oldest son to stay with the young ones. I basically ended up finding my daughter at the morque.

She was -- she left a five-year-old behind. Where he asked me yesterday, after almost a year that she's been gone, "Mommy, grandma, if I have baby Luna in my right hand and I have mommy in my other hand, why Jesus don't hurry up and let them go, so they could come home?" He was just pronounced last week with PTSD, post-traumatic stress disorder for being only five years old. Not only him, his little brother that's ten, which my husband passed away five years ago from a drunk driver, as well. And so, my ten-year-old is going through the same thing twice.

So, how can I -- how can I try to push this kids forward and tell them grow up, do the right thing, get your license, when half of the time I'm scared to drive myself. I pray to God every day for

strength and for power. When I'm feeling down I call Liza. When she's feeling down, she calls me. She become my best friend. Every single day I don't sleep. I don't speak. Seeing my kids, her five-year-old that I have, he's in my custody now, how do I explain to him when that given time comes, how did his mother die. I'm not ready. I'm not ready. It hurts when a five-year-old tells you, my soul is broken. This little kid is so bright. only five years old and he's taking second grade classes. We push them. With my ten-year-old son -my ten years old son becomes a role model for my five-year-old grandson. So, it's hard. Please take it into consideration with this Bill. We need this. Thank you.

REP. STAFSTROM (129TH): Ma'am, your -- your loss is unimaginable, both and your strength to be here and to testify, and as was said by a previous speaker, there are a lot of us who are parents and have our own kids. And I think, you know, we -- we all are -- there's certain nights we leave here and it's one of the hardest things about serving on this Committee that you just want to go home and hug your own kids. And because, you know, it's just such reminder of how precious life is.

But your strength to be up here, to be able to testify before us, to talk about your experience, and to -- to advocate for change, I think is -- is certainly an inspiration to all of us. I think, I -- rom the comments I've heard, if our rules allowed us to take a vote on this Bill right now [laughter] and vote it out, it would -- I'm not sure there would be a no vote [laughter], I highly doubt it. But I -- I again, I just want to -- want to express to you and -- and to everyone here today on

behalf of the Committee how serious that we take this and how, you know, there's a reason we do these public hearings. There's a reason we sit here since 10:00 o'clock in the morning, and it's because they do make a difference. And your testimony does make a difference. And so, I wanna -- I wanna thank you again for -- for --

JULISSA TORRES: Thank you.

REP. STAFSTROM (129TH): -- your strength and your advocacy. Further questions or comments? Thank you very much.

JULISSA TORRES: Thank you.

REP. STAFSTROM (129TH): Rosa Sanchez?

ROSA SANCHEZ: Uh-huh. I'm gonna try and get through this as quickly as possible. Good evening, ladies and gentlemen. I'm sorry. As a parent, I can't imagine losing my child. My daughter is 30 years old and having her second baby. I'm so sorry. So, I am co-workers with the Herreras, and my heart goes out to them. And I don't want to support Bill 7378 because I agree with everything that I've heard here today in terms of giving youth more and getting them involved in more. However, in this particular case, the youth was 19 years old, the husband of Briana who put them at risk with complete disregard. Walking around, driving, license is suspended. I think this is the real reason why we all are here to try and make a difference. We're not talking spend 20 years in jail, but we are saying a more severe penalty needs to take place. And if we were going to compare to DUI, it should be held at the same standards, because that's reckless endangerment to everyone in the vehicle and pedestrians alike.

I -- when I leave work, I want to go home not thinking that, you know, some irresponsible jerk out on the street decides, hey, I'm gonna race today and there goes everything. It's just so very important to make this happen. And I wanna thank you for giving us the opportunity to share that with you.

REP. STAFSTROM (129TH): Thank you. Questions from the Committee? Thank you very much. Tondaloa Ivery? Yeah. This -- yeah, I know we have a couple folks sign up on the bottom. Anybody else from this group? Let's -- let's do it this way, why don't -- is there anybody else from this group, so we can get -- get you guys home, because I know it's been a long emotional day.

JESUS HERRERA: I'm gonna -- I'm gonna ask to excuse myself and what I want really, thank you very much for your service. It's been a long day. And you guys sit there listening to us. So, I really appreciate and -- and any support from you guys would be really appreciated. Both families appreciate it.

REP. STAFSTROM (129TH): Absolutely. Thank you.

JESUS HERRERA: Thank you so much.

RAQUEL ACUNA: Good evening members of the Committee. My name is Raquel. I'm just going to echo a little bit. I'm here in support of the <u>Bill 7378</u>. I support this Bill -- this Bill, because I feel that anybody who has killed others in a car accident due to illegal racing and negligent homicide with a motor vehicle should pay the price. When you get into a vehicle and choose to race, you're not only putting yourself in danger but you're putting others in danger as well as who may

be drivers around the road, pedestrians, and most importantly, the people in the car and yourself.

Shalymar's life was cut loose because of the mistake and poor judgment of someone else. The driver of the vehicle she was in, didn't take in consider of the other people he had in his car that day and raced, carefree, causing the horrific accident that took the life of Shalymar Herrera, as well as Briana and baby Luna. She was one of my best friends and had completed so much in such a short time, and she was a hero to our country who vouched to save and protect our nation in the Army.

Not only were the victims robbed from their lives and dreams, but they were robbed from their families, their friends, and other opportunities that they had to grow in life. Anyone that — that would bring grief to others by taking away a family member due to illegal racing and — and negligent homicide with a motor vehicle, should pay the price. Thank you again for giving me the opportunity to express myself and as to why I agree with this Bill. Thank you.

REP. STAFSTROM (129TH): Thank you. Just identify yourself for the record, so that we've -- we've got it.

AMEILA SANTOYO: Good afternoon. My name is Ameila Santoyo and I am standing here in support of the <u>Bill 7378</u>. Not only am I supporting this Bill because of the lives that were lost on April 8th, 2018, but because it is unfair to those who have to deal with the pain that comes after a traumatic event like this one. You never know what can happen or you never think this is going to happen to you or someone close to you until it actually happens. The

aftermath is harder than you and it doesn't get easier. You only have to hope and have -- you only have to hope and have faith things get better. Grief is something many of us have been dealing with since April of 2018. The passing of this Bill should be implemented and increased in getting higher censuses, having your license suspended or taken for a long period of time. You should not have to be afraid of getting in the car with someone else. You shouldn't be having thoughts whether your life will end or not because of the irresponsibility's others decide to make. People make decisions without the care of others but theirselves. They only think of the moment.

The highest level of participation is males around the ages of 15 to 23 years -- 23 years old. Each year, there has been approximately 37,000 motor vehicle accidents in the US. During 1998 until 2001, there has been at least 399 fatalities which over the years has been going up. No one should be out on the streets living life as if they didn't do any harm. We should come together so they can be responsible for what these drivers do. Not only that but it's sad having to go to court every month and seeing the people that did this with no remorse.

Like we said, it's like they're -- they're out there living their lives and they probably suffer, but we're the ones suffering more because Shalymar is not here. I grew up with her since I was a little girl. And although I didn't know Briana, she -- what I've heard, she's amazing. She left a little boy. Her baby was pronounced deceased at that time, too. Every time I go over to Liza's house, you know, it's sad having to go to sleep over at your friend's house and your friend is not there. And

what hits me the most is when I see her little brother, he's always like desperate because he doesn't know what to do. He always comes to me and whenever I'm around, he just wants me to play with him because he has nobody else to play with. They all hurt in silence. We all hurt in silence.

And they're still out there living their lives, not -- with like no care in the world. When -- it's sad. And we just want the investigation to be over with. We want the trial to start. We're tired of going to court, having everything pushed back and pushed back and pushed back. Nothing ends.

REP. STAFSTROM (129TH): Thank you. You girls -you girls are remarkable for coming up here, for
sitting here, and -- and for being so strong in your
testimony. Questions, comments? Thank you both.
Anybody else who hasn't had a chance to testify that
wants to? If not, we -- we wish -- we wish you
absolutely all the best. And I -- I assure you we
are going to take this very seriously. And -- and I
anticipate that this Bill will move out of this
Committee in the next couple weeks. So, thank -thank you all very much.

Okay. I know we have a couple of other folks who are still here who want to testify. I'm going to call them. And then, we'll see if there's anybody I missed. Noemi Soto. Just make sure you hit your microphone button there and turn that on.

Mr. Chairman and members of the judiciary committee,

On April 8, after a seemingly fun night at Shelton's SportsCenter, we lost soldier PFC Shalymar Herrera, a mother Brianna Torres-Carter, and her unborn child, Luna Rose. We often ask ourselves what could I have done? I saw her final snapchats the next morning and I listened to her yell to the driver "don't get hit!" I ask myself if I saw those sooner - would things be different? We often believe our actions could have changed time and stopped this day from happening - however, it is often too late.

Despite legislature penalizing operators for the death of another person, a lost human life cannot be equated to a mere \$2500. Street racing is foremost illegal, reckless, and dangerous. It is a deadly game that puts the driver and innocent lives at risk of death or serious injury. Many are now recognizing that more must be done which is why proposed bill #6720 will prevent unnecessary deaths such as my closest friend Shaly, Brianna, and Luna.

A lack of federal, legislative, and educational efforts to combat illegal street racing will cost more lives if nothing is done to increase penalties which will deter many to street race and spread awareness through educational efforts. Although Connecticut may not have the highest number of total fatalities due to speed-related crashes, we have the opportunity to be leaders in setting a strict tone for illegal street racing to prevent more deaths.

To address this problem, an increase in penalties for negligent homicide and first offense of illegal racing, as well as a 15-hour mandatory reckless driving class, would provide the necessary preemptive steps to combating illegal street racing. Testimony in Support of H.B. No. 7378 An Act Concerning Negligent Homicide with a Motor Vehicle and Illegal Racing

Good afternoon, Chairmen Rep. Stafstrom and Sen. Winfield, distinguished ranking members and members of the Judiciary Committee, I am here to testify in favor of <u>H.B. No. 7378</u>, An Act Concerning Negligent Homicide with a Motor Vehicle and Illegal Racing.

This bill would provide an increase in the current penalties on offenders. Negligent homicide with a motor vehicle occurs more often than it should and currently the penalties in our general statutes do not adequately represent the gravity of losses sustained due to these actions.

Currently students are instructed in safe driving habits and skills in driving school as well as the highway transportation system; analysis of crashes; roadway designs and markings; risk management techniques; and Connecticut's motor vehicle laws and regulations.

Although these areas are taught in a full duration driving course, the eight-hour mandatory course includes only four hours for the nature and effects of alcohol and drugs, and only two hours of safe driving practices.

According to Sec. 14-224(c) "No person shall operate a motor vehicle upon any public highway for a wager or for any race of for the purpose of making a speed record"

This makes Connecticut law one of the most permissive with respect to criminal penalties regarding negligent death regarding a motor vehicle and illegal racing.

According to the state of Connecticut Penal Code updated and revised as of March 2nd 2018, as to criminally negligent homicide with the use of a motor vehicle (14-222a) a sentence of less than six months imprisonment and a fine of two-thousand five hundred dollars is the current maximum sentence.

Among our streets and our highways there has been a long-standing issue of injury and death due to reckless driving from illegal racing, and negligence from adhering to the safe driving laws.

Drivers receive an education on the proper rules and regulations of the road and administration of the consequences, but although in a lot of instances people are injured or lose their lives by supposedly fully trained drivers with no adequate consequence.

This bill raises these penalties, not only as a mean of deterrence, but to provide the families with a sense of closure, justice and safety.

I am writing to you regarding increasing the penalties for negligent homicide with a motor vehicle.

My name is Sonia Henry, I am Felipe Peter Soto's Mother, he's lovingly known as Petey. As a Mother, I need to ensure I do everything I can within my power to accomplish my goal in receiving Justice. Whenever my son's killer went to court, I went, never missing one of his court dates. Had I known or have been made aware regarding today's hearing for increasing the penalties for negligent homicide with a motor vehicle I would have certainly attended. Should you have a distribution list, I would like to be included on your list.

My son's murderer, David Henshaw received only 3 years (which, I had to fight very hard for) as he drove at 140 mph on a 25 mph street and his recklessness, his disregard for the law and especially a human life, cost my son that of his, my grandchildren their father, his siblings a brother, and his father and I, our son. This was a heinous and senseless murder! My son was dismembered, his body cut completely in half, not only was he decapitated but the entire back of his head had to be sewn together in order for my family to view him privately, his body parts wrapped in blankets. He was disemboweled on the streets of Bridgeport. A nurse who ran to help my son found his foot first, his head and upper torso by a tree and his lower half by another. I could not touch his hand or hug my son I was specifically told in a loud voice, DO NOT TOUCH HIM. David Henshaw not only murdered my son but he took away my right to touch my son one last time... (One that most people get).

When I think of Justice and all that I had to do to fight for Justice has been extremely frustrating. For almost 3 years now I have been disappointed, disgusted and appalled with the way my son's case has been handled and the disregard of my treatment. I believe officials have become Immune, Accustom and Desensitized to the victims and their families as they deal with it on a daily basis. My experience regarding empathy has been almost nonexistent. Thus far, I feel as if the City of Bridgeport has been a disservice. I have never felt so insulted, discouraged and devastated in all my life.

Why have street signs, why have speed limits, why have laws if people will continue to disobey them. It makes me wonder if anyone cares about the law, if anyone cares about a human life? Henshaw drove 140mph on a 25mph street as if it meant NOTHING to him, dismembering and decapitating my son's body, meant absolutely nothing! What you allow is what will continue... People will not respect the law and think they are above it and can do anything they want all while getting away with Murder! Where are my son's rights? I am overwhelmed with grief and the damage it can do to your mind and body, it has wreaked havoc on our entire family.

My son was Felipe Peter Soto, only (and now forever 31), you may not have known him, but we all do. He was hardworking, loving, hysterically funny, intelligent, empathetic, a great listener, handsome, caring and had the most contagious smile. But most importantly he was a son, brother, father, nephew, cousin and friend to countless people. He always spoke highly of me and made it known just how much he loved me as well as his children. His presence was so entertaining he could engage anyone in conversation.

We love him, we miss him, we cry for him, we mourn him with every fiber of our being. Both Petey and his children Nicholas and Elissa who were 5 and 4 years old, were robbed of precious time with their father, he can no longer nurture, educate, play or hold his children. He cannot take pictures of their first day of school, attend a class field trip, take his daughter to a father/daughter dance, plan a family vacation, attend their graduation, teach them how to drive, walk his daughter down the aisle, give fatherly advice, or hold his future grandchildren. HE was an amazing young man with a beautiful heart, a passion for life and a promising future until David Henshaw abruptly ended it. David Henshaw has been taking advantage of the system for almost 3 years. He is a fortunate man because he continues to live, sleep, eat, celebrate birthdays and holidays while my son is mere ashes in a box. I am terrified of holidays as they are a harsh reminder he's no longer here. I'll never see my son grow old, celebrate his birthdays, hug him, kiss him, talk or ever see him again. I feel as if I die a little every day. My chest is tight, my heart hurts terribly, it's an excruciating pain. I have no choice but to talk to his picture.

My son's death certificate lists his death as an accident, I couldn't disagree more ~ driving 40 – 45 on a 25 mph street might be considered an accident, but driving 140mph on a 25mph street for 5 blocks is Murder! In the words of Chief AJ Perez "Worst scene he's witnessed in his 34 years of service. Horrific scene, it looked like a bomb had hit that car". I hope, pray and beg that you please increase the penalties for negligent homicide with a motor vehicle. I only ask that you please let us know there is a justice system that takes these matters seriously.

My name is Liza Herrera, I am here with my husband Jesus Herrera to support <u>Bill #6720</u>. Our inspiration is our beloved daughter PFC Shalymar Herrera, who <u>on April 8</u>, was tragically killed in a car accident in Shelton. The driver of the car in which she was a passenger, impulsively decided to street race with another driver on River Road in Shelton, CT .As was discovered in the course of the investigation, both drivers were found to have exceeded 80 mph when the accident happened, (The speed limit in River Road ranges from 35 to 45 mph). The crash not only took the life of our precious daughter; but it also took the lives of other passengers including Briana Torres and her unborn baby Luna ,who was due to be born in a month, and had sufficient physical development

to be born had she too not been mangled and killed as a result of the accident. This racing incident also caused serious injuries to innocent passengers of a third car, which just happened to be passing through on that road.

We can't begin to express the depth of our grief for the loss of our 18 year old daughter, who was a loving sibling and best friend to her brother, Our 11 year old son Jelian. Shalymar was everything to us, she was the most perfect daughter we could ever ask for, and our lives will never be the same without her. She had a promising and exciting future ahead of her. She had finished Army training, and brought home 2 Army achievements awards including a Medal, and was about to attend The University of Connecticut in Stamford to fulfill her dreams of becoming a Veterinarian to reflect her love of animals. Shalymar's hopes and dreams were all about making a positive difference in the lives of others. But all of that was taken away suddenly and brutally, because of someone's careless decision to get a cheap thrill from street racing.

I know that every one of you Legislators are grateful for our soldiers. Well our Shalymar was a proud soldier in the United States Army, who was willing to put her life on the line to protect your freedom and mine. Never would she have guessed that her life would be snuffed out as a result of a senseless act of street racing.

Illegal street racing in Connecticut is a problem that has not been properly addressed. Currently as the law stands:

Sec. <u>14-222a</u>. Negligent Homicide-Motor Vehicle- The actual penalties are not more than one thousand dollars or imprisonment not more than six months or both.


Sec.14-224 Illegal Racing on Highway- Fined not less than seventy-five dollars or more than six hundred dollars or be imprisoned not more than one year or be both fined and imprisoned, and for any subsequent offense shall be fined not less than one hundred dollars or more than one thousand dollars or more than one thousand dollars or be imprisoned not more than one year or be both fined and imprisoned. The court may order such motor vehicle to be impounded for not more than thirty days.

I am very grateful to have this opportunity to at least start this process of making changes to the existing law regarding penalties for illegal street racing and negligent homicide with a motor

vehicle. However, ideally, going forward, I would like to see these penalties increase even more, so they will have even greater power to deter would-be street racers before they even set foot into their car, based on a rush of adrenaline and the promise of a momentary thrill that could take human lives.

We kindly thank you for your consideration and your time. The passing of this bill is extremely important to us. Please help us to lower the likelihood of this happening to other families. We are trying to piece our family back together again, but it will NEVER be the same. You have the power to help us take this small step in making a positive change. Please pass Bill 6720.

Statement by TondaLoa Ivery

I thank God for the opportunity to speak before you this morning. My name is TondaLoa Ivery, we have obviously never met but I believe it was meant for us to meet one another today and I am grateful. I am a disabled veteran that served in the United States Army on active duty from November of 1985 through March of 1993. I went on to serve in the United States Army Reserve for an additional 11 years after that. The military family is unique, we share a common bond, distinct lifestyle and we are taught in the first 8 weeks of training the importance of our job, but more importantly our connection with one another as fellow soldiers. We understand that the people we serve with know many of things we go through and they have the potential to help us survive in life threatening situations. I didn't have the opportunity to serve during the same time that Private First Class Shalymar Herrera served but I stand before you this morning and in the presence of everyone here to let her know that I got your SIX PFC Herrera! (I got your back)

I had the pleasure this weekend of speaking to one of my childhood friends, and we spoke in depth about life choices. I want to let you know this morning that in my heart I feel that this is the underlining theme to what this moment is about people made choices. We recognize many of the choices PFC Herrera made about her young life, but we also must recognize that on April 8th, 2018 two young men also made a choice that would affect the lives of many.

One of the important lessons about the choices we make are the consequences of those choices. When we look at the Connecticut Negligent Homicide with a Motor Vehicle law, we find that in most cases conviction carries up to six months in Jail and or a maximum \$1,00.00 fine. Interesting to me in Connecticut negligence is generally a person acts with negligence by failing to use the care that a reasonable person would under like circumstances. The definition even goes so far as to suggest that a person who fails to wear corrective lenses, would ordinarily fall in this category.

This leaves us perplexed, we cannot imagine that someone who failed to wear corrective lenses, and someone who chooses to race a motor vehicle with another motor vehicle and causes the death of passengers in that vehicle could both be considered negligent and receive the same sentence.

Here we are back to the place of choices, we believe that as parents, and family members the one thing that persuades the majority of the people against breaking the law, is the consequences of the act, the penalties that can change your life forever, but in this case the

penalties are so remarkably low, I can't see where the penalty carries the weight to alter the behavior. It is within your power today to make the choice to be a part of the change that would truly hold people accountable for their actions. Hear us today and support HB #6720.

It is my honor and privilege to come before you today to show support for the proposed bill 6720 which would increase the penalty for negligent homicide with a motor vehicle and illegal racing.

My name is Dr. Raeleen D'Agostino Mautner. I am from Wallingford CT. I hold a research PhD in psychology and after many years of teaching in the universities I began to work directly on research studies at Yale, and now presently coordinate a large research study at the CT VA Healthcare system to benefit our veterans. It is in this capacity that I came to know Liza Herrera, mother of Shalymar and Jelian Herrera and wife of Jesus. I now feel honored to know them all, as I observe their tremendous courage and good will through the most traumatic experience anyone could ever have to face—the loss of their precious daughter and sister, Shalymar Herrera.

I have known Liza for approximately 5 years. Like everyone else who knows her—I was always taken by the infectiousness of her joyful smile. She was and is—a loving mother, a devoted wife, and a hard and honest worker.

For the last year, that characteristic smile I used to see once upon a time--has given way to frequent tears that reflect the broken heart of a mother who lost her child; her only daughter, her flesh and blood.

The dictionary defines the word "negligent" as "failing to take proper care of something". Negligent homicide, then, would imply failing to take the proper care to safeguard someone else's life. There is not one of us in this room who would even think of putting another human being's life at risk. Most people don't. Most street racers don't think about it ahead of time either. And that is part of the problem.

From the sparse data we have on this subject, drag racing is usually spontaneous, driven by the thrill of an adrenaline rush, predominately carried out by young males who are between the ages of 16 and 25, who typically perform other risky and delinquent behaviors as well.

While there is no simple or one-size fits all solution to this ever growing and widespread problem, making a punishment strong enough to serve as a deterrent is at least a start. It will hopefully FORCE would-be racers to think about the very real consequences that would put a damper on their tendency to want to go through with a street race. Harsh consequences that can affect racers personally and in an adverse way, even if the thought of their own mortality isn't a tangible enough image ---may make a positive impact. In Rialto California, for example, a few years back, teens meticulously souped-up cars were confiscated and crushed, in an attempt to crackdown on illegal street racing in Southern California. That was indeed a strong enough punishment to have some effect.

Those who lose their lives as a result of street racing are not limited to the racers and their passengers, but often they are people like you and me who don't even personally know someone who drag races.

Some examples include:

*A North Carolina English professor and her 2-year-old daughter, whose care was slammed into by a street racer.


- A Florida grandmother innocently walking down the street and run down by street racers.
- In north Milwaukee a 60-year-old man riding his bicycle to work was struck and killed by a 13-year-old girl drag racing in a stolen car,
- 33 year old Cynthia Younker, of Greenville, Mich., killed by a drag racer who was driving up to 120 mph when he crashed into Younker's motorcycle.

The list goes on.

Passing this bill may not only serve as a deterrent, but may also help to bring more awareness to the community, ---a community which should includes parents, teachers, doctors and religious leaders who are in a position to help disseminate information about the consequences and risks associated with drag racing.

The Herrera family is turning their pain into positivity by striving to make improvements in a law that is currently surprisingly lenient. I implore you to help them to make an important difference in the safety of our communities by passing bill# 6720.

While all horrific car crashes like this one can never be completely prevented, House Bill Six Seven Two Zero takes a very important step in reducing the chances that this tragedy will happen to another family or community in Connecticut in the future. Not only does House Bill Six Seven Two Zero increase the penalties of negligent homicide with a motor vehicle and illegal racing to ensure that offenders of these laws suffer just

consequences, but it also mandates that offenders of illegal racing laws have to complete fifteen hours of a reckless aggressive driving class for each offense of these laws. This requirement will allow for offenders of these laws to learn about the dangers of their actions and they will return to the roads as safer drivers, greatly reducing the risk of the tragedy that happened to our community from happening again.

House Bill Six Seven Two Zero has a sizeable amount of support, an online petition was circulated to gauge the level of support we have, and we received well over four hundred signatures. When voting on this bill, please vote on it as if this were your child or loved one in a crash like this one, because it could be. What one driver does on the road affects not only themselves, but also their passengers, all the other drivers and

Madame Chair, Mr. Chairman, and Members of the Committee:

My name is Sheila Oppenheimer of Fairfield, Connecticut. I appear before you to support the proposed amendments to bill 6720, to increase the penalty for negligent homicide with a motor vehicle involving illegal street racing. [to a fine of not more than \$3500 or imprisonment of not more than three years or both] and that section 14–224 of the general statutes be amended to increase the penalty for a first offense of illegal racing to a fine of not less than \$150 or more than \$600 or imprisonment of not more than one year or both and mandatory completion of 15 hours of reckless aggressive driving class and in the case of any subsequent offense of illegal racing to a fine of not less than \$300 or more than \$1000 or imprisonment of not more than a year or both mandatory completion of 15 hours of a reckless aggressive driving class and a 60 day suspension of such person is motor vehicle operating license.

Last April, shortly after I arrived at work, I received a call from my son Sean. He informed me that Shalymar, the lovely young lady whom he had taken to the prom two years prior, had been killed in a motor vehicle accident on the previous evening.

Two others died as well - a 23-year-old woman named Brianna Torres, pregnant with a baby girl. Her baby shower had been celebrated the night before. Briana died, and despite the best efforts of first responders and medical personnel, the baby died as well. Her name was Luna.

This tragedy occurred in the context of illegal street racing. Two other cars were involved - one racing, the other carrying three unwitting passengers who crashed head-on into one of the racing vehicles.

Members of the committee, there are no words, there are no ways which could adequately express the sorrow and sadness to which I bore witness following this tragedy.

Shalymar Herrera was 18 years old, a Private First Class in the United States Army. A proud member of the Civil Air Patrol, Shaly had graduated from Bridgeport Military Academy. Shaly planned to attend the University of Connecticut to pursue a career in veterinary medicine. Everyone loved Shaly.

Five days later, I stood on line at Shalymar's memorial service to pay my respects to the Herrera family. There at Shaly's casket stood her mother Liza, delirious with grief. Her father Jesus, stood vigil over Shalymar, not leaving her side. Her younger brother Jelian stood with his parents. The line stretched around the city block.

I have attended many funerals in my 51 years on this earth, but never, never like the one of Shalymar Herrera. The image of her parents standing next to their daughter, her brother standing next to his sister at her casket will forever be seared in my memory. There are times for me when it's hard to think about anything else. But her family! living in the house where their Shalymar lived, passing her empty bedroom, eating at the table where her chair stands empty, recalling Shaly's presence in every square inch of their house.

Somehow on that night of April 8th, the drivers of these two cars thought that illegal street racing was a good idea, and now we are left without precious Shalymar, Briana and Luna.

Please amend <u>Bill 6720</u> to raise awareness and fear of significant consequences to deter and prevent this senseless, reckless tragedy from occurring again.

My name is Diane Wilczewski, devastated and grieving mother of Courtney Wilczewski. I just found out that there will be a public hearing on Monday, March 25th. I am away and unable to attend with such short notice but feel very strongly with respect to the bill <u>Raised House Bill-No. 7378</u>, An Act Concerning Negligent Homicide with a Motor Vehicle and Illegal Racing. Our family 100% support this bill because of our personal situation.

Our precious daughter and sister, Courtney Wilczewski – age22, was killed on May 26, 2015 by Felix Pagan. This was not an accident but a careless disregard of his medical condition which caused a head on collision with our daughter ending in her tragic death. Charged with negligent homicide, he only spent 30 days in jail and a short 18 months on probation. How can anyone justify someone only serving 30 days in jail for causing the death of another? Dealing with the loss is horrible enough but then to find out the laws are so lenient is another knife to our hearts.

Life without Courtney is beyond difficult. To this day it is hard to catch my breath. I have yet to find the perfect words to describe the daily pain without her. It is an ache so deep in our hearts and souls that it is immeasurable. Our family's life since that day is defined as Before and After. It is impossible to explain to anyone how much Courtney is loved and missed. We can only tell you that our suffering has not and will never end. I live with unimaginable visuals and memories from the accident scene, frustration from the unfair process and exacerbated medical issues since her death.

Nothing will ever bring our Courtney back. Knowing that in some way we could help future victim's families makes us hopeful. I implore you to pass this bill. The additional time and higher fees might just deter someone from making a bad decision and save someone's life. Our family would have felt just a little better knowing that the person that killed our baby was being held more accountable.
